

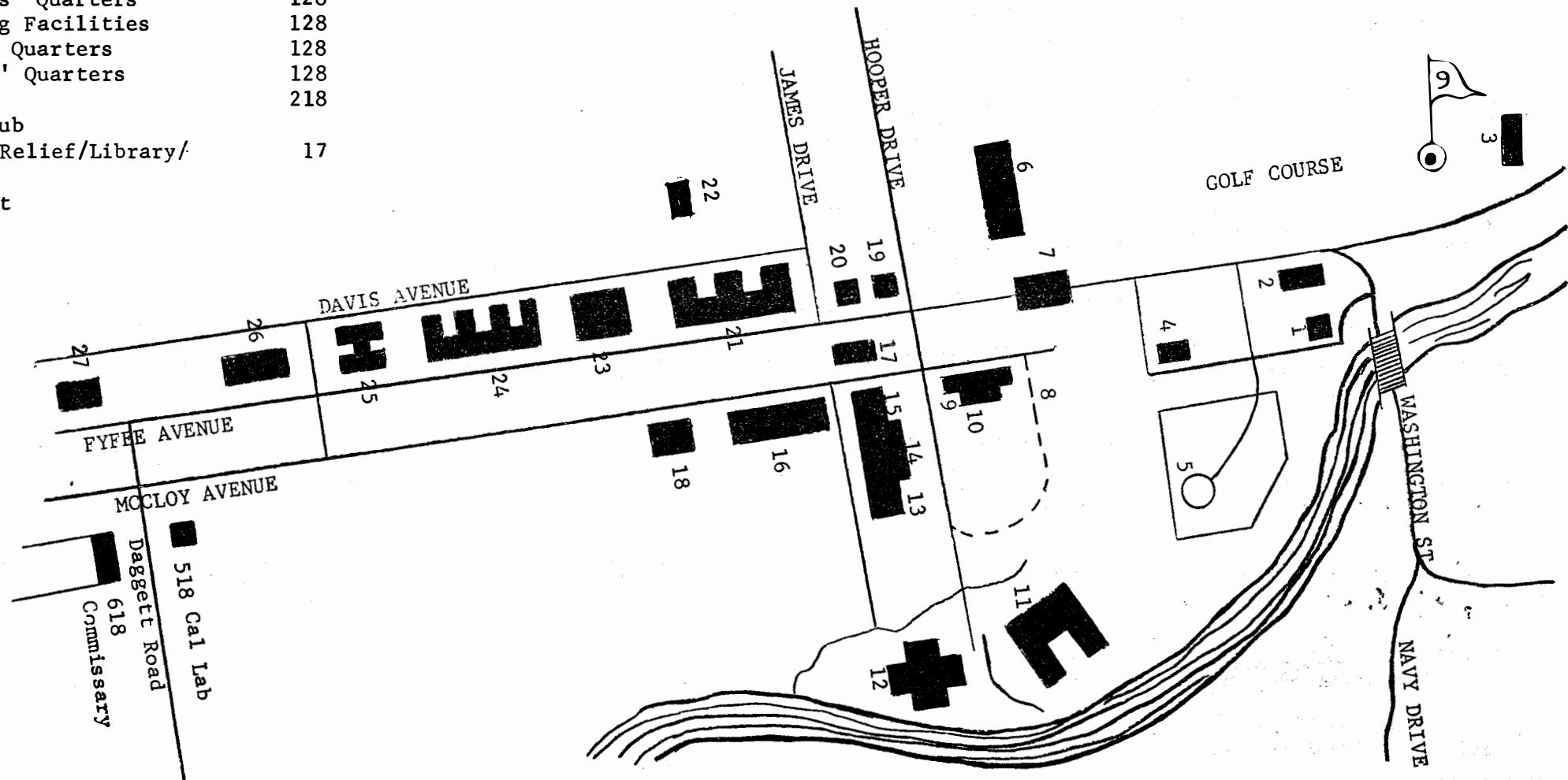

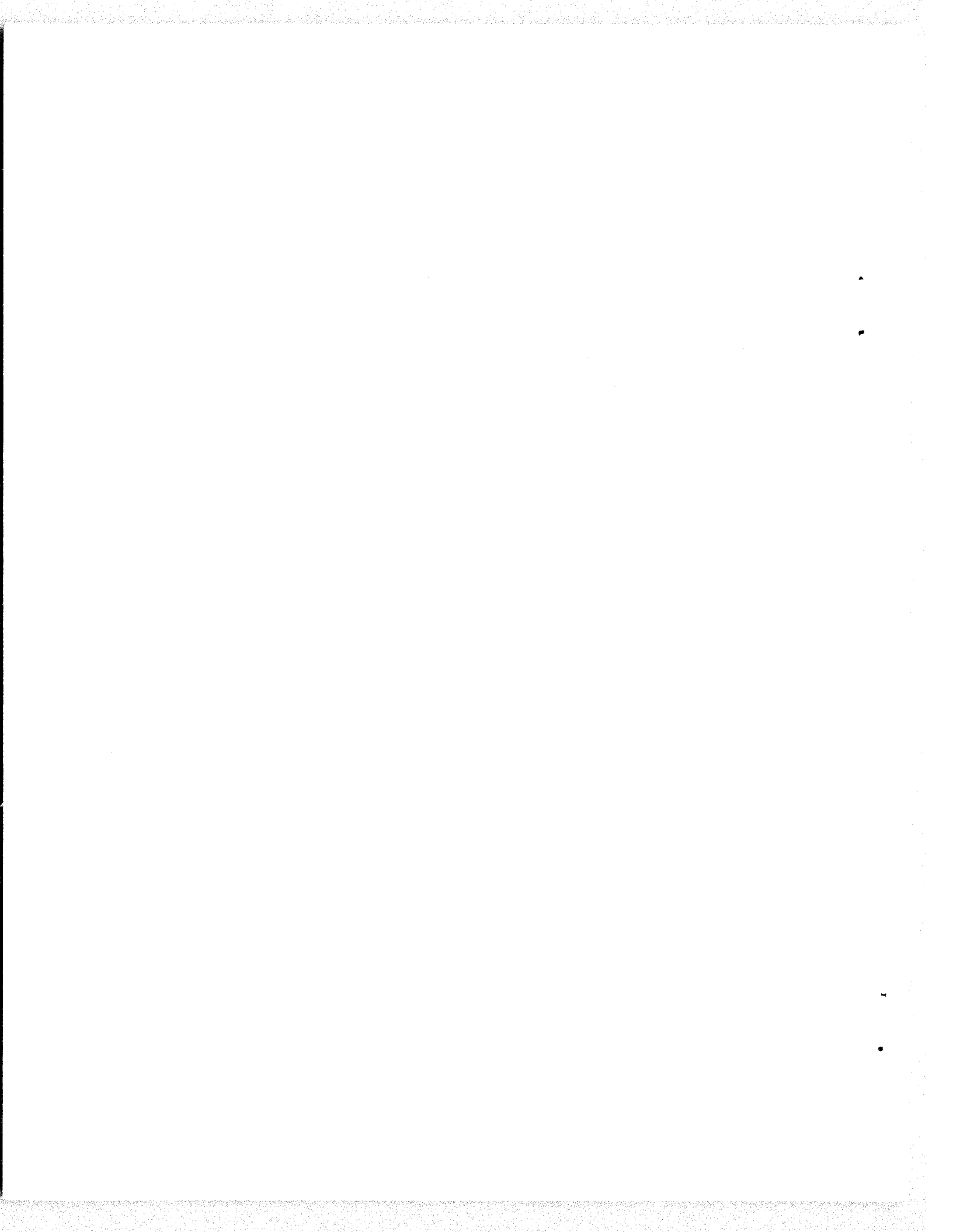
WELCOME ABOARD

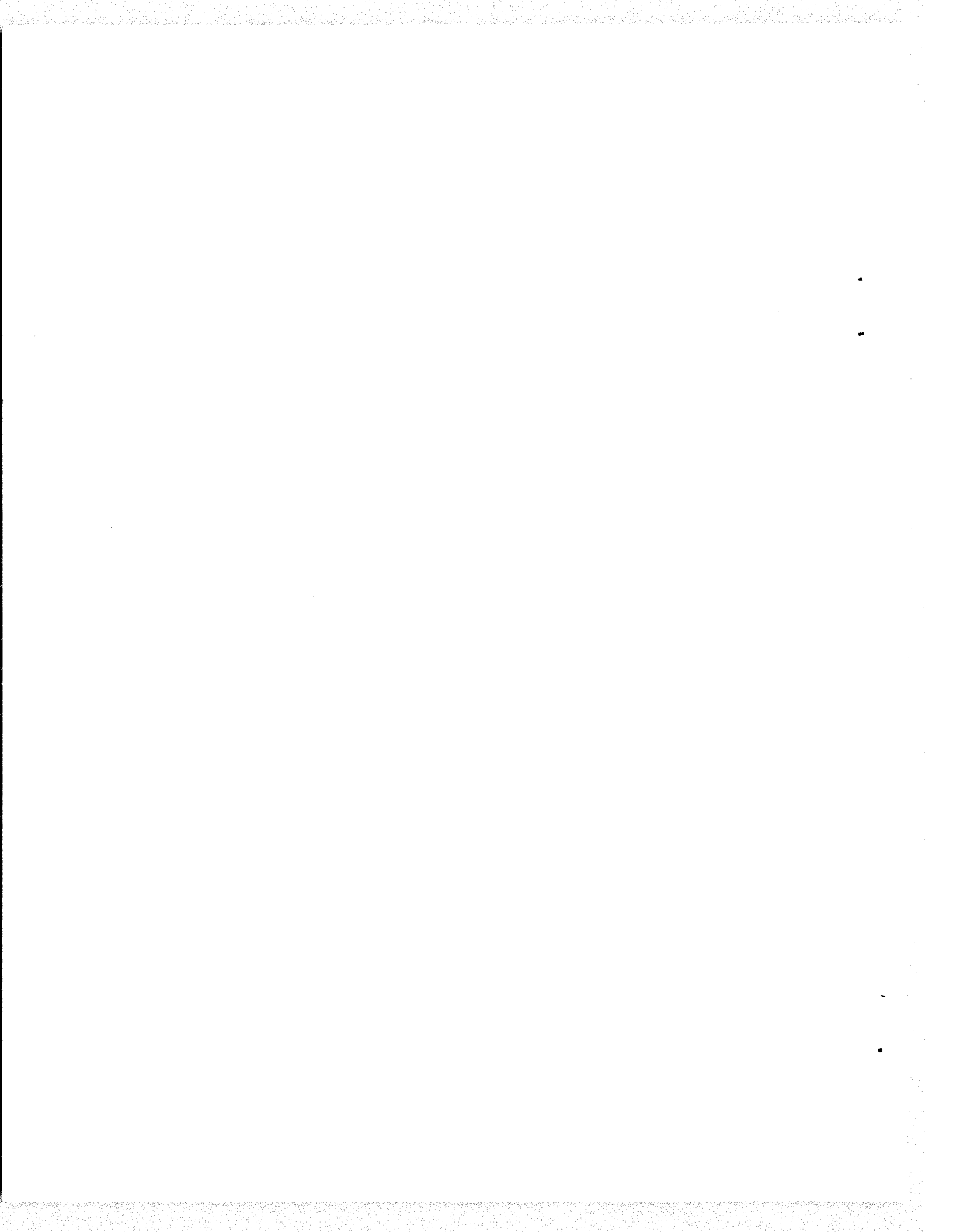

## SECTION ONE - COMMAND OVERVIEW

### MISSION

As an activity of the Naval Communication System, to manage, operate, and maintain those facilities, systems, equipments, and devices necessary to provide requisite communications for the command, operational control and administration of the Naval Establishment; to manage, operate and maintain those facilities of the Defense Communications System as assigned; and to perform such other functions as may be directed by the Chief of Naval Operations.

### GENERAL INFORMATION

Naval Communication Station Stockton is comprised of the Headquarters, located at Rough and Ready Island, Stockton, California and eleven component activities, widely dispersed geographically. These include:

1. Naval Telecommunication Center Bangor
2. Naval Radio Transmitting Facility Dixon (under contract operation)
3. Naval Radio Receiving Facility Skaggs Island (under contract operation)
4. Naval Telecommunication Center Concord
5. Naval Telecommunication Center Mare Island
6. Naval Telecommunication Center Oakland
7. Naval Telecommunication Center Alameda
8. Naval Telecommunication Center Moffett Field
9. Naval Telecommunication Center Monterey
10. Naval Radio Station (T) Jim Creek
11. Naval Telecommunications Command Operations Center Detachment Sunnyvale

All personnel ordered to NAVCOMSTA Stockton will be assigned either to the Headquarters element or to one of the component units above.

For this reason it is important that you do not move your household goods or buy a home until you have received a definite assignment of duty location. A sponsor will be assigned all incoming personnel. Your sponsor will provide

details of tentative assignments, but final assignments to locations will be made only by the Executive Officer.

## HISTORY

The Naval Communication Station (NAVCOMMSTA) Stockton enjoys the distinction of a proud past, dating back to the beginning of Naval Communications. It was first established in 1904 at Mare Island Naval Shipyard as a small radio station built in a converted pigeon loft. It was the only West Coast station of a system that formed the foundation of today's Naval Communications System.

In 1917 the Naval Communication Station Stockton (then NAVCOMMSTA San Francisco) was established on Yerba Buena Island in San Francisco Bay, with Mare Island acting as the remote transmitting facility for the new station. In 1920, NAVCOMMSTA moved to San Francisco, next door to the Twelfth Naval District Headquarters. In 1925 the NAVCOMMSTA moved again, along with Twelfth Naval District Headquarters, to the newly built Marine Corps Supply Depot on Harrison Street in San Francisco.

At that time the Receiver Site was moved to the Hillcrest district in South San Francisco. In 1935 the station, in company with the Twelfth Naval District Headquarters, relocated to the new Federal Office Building in downtown San Francisco, and in 1942 Skaggs Island became the new remote Receiver Site. Continuous growth and establishment of the fleet communication facilities eventually led to a new transmitting site at Dixon, California. By 1955, it became evident that the quarters in the Federal Office Building in downtown San Francisco were inadequate to cope with modern day communications, and therefore, in 1960, NAVCOMMSTA Headquarters, with all its control facilities for linking the various branches of the command, was moved to Rough and Ready Island, near Stockton, California.

The Station as it now exists has the reputation of being one of the best and most modern of all Naval Communication Stations with a complex consisting of the Headquarters at Stockton, California; Radio Transmitting Facility, Dixon, California; Radio Receiving Facility Skaggs Island, Sonoma, California; and Naval Telecommunication Centers (NTCC's) at Oakland, Monterey, Mare Island, Concord, Bangor, Moffett Field and Alameda, and NTCOC Sunnyvale. The microwave repeater stations on top of Mt. Diablo and Mt. Vaca tie many of these activities together. Naval Radio Station (T) Jim Creek, Oso, Washington is an Echelon IV activity under NAVCOMMSTA Stockton.

Approximately 360 military and 440 civilian personnel are members of the family called Naval Communication Station Stockton.

## SECTION TWO - HEADQUARTERS NAVCOMMSTA STOCKTON

### BACKGROUND

The Headquarters of the Naval Communication Station is located on Rough and Ready Island, four miles west of the city of Stockton, California. Rough and Ready Island has a rich heritage predating the arrival of the U. S. Navy in 1942.

Originally marshy grassland and swamp, home for migratory birds, waterfowl, and other indigenous marsh creatures, the island was often flooded over by the San Joaquin River. At one time it was an Indian burial ground and some Indian artifacts were unearthed during construction of the Naval Supply Annex here in 1942-1944.

The first settler arrived here in approximately 1850 and was believed to be a sometime miner by the name of "Napoleon" who had come from the Mother Lode gold rush town of Rough and Ready. The town itself, and likewise the island, were named in honor of General Zachary Taylor (12th president), who earned the nickname "Old Rough and Ready" for his actions during the U.S.-Mexican War of 1848. "Napoleon" and his successors reclaimed the fertile land from the river with dikes (some built by Chinese laborers) and planted fruit orchards.

The first military installation on the island was an army camp built here after World War I. It was used to rehabilitate wounded war veterans.

The present CO's Quarters; (Quarters A) was at one time the home of a wealthy Stockton lawyer; George Buck. The house has hosted various dignitaries, including former President Herbert Hoover, and remains a landmark well known to the Stockton community.

During World War II, Rough and Ready Island served as a prisoner of war camp for captured German and Italian soldiers from the North African Front. These prisoners built many of the island's roads, drainage ditches, and masonry work.

The island was built up as a major supply depot for the planned invasion/offensive against the Japanese home islands and it became the site of the U. S. Naval Supply Annex in 1945 (commissioned June 30), subsequently becoming Headquarters for the Naval Communication Station in 1960.

The end of the Korean Conflict brought a gradual decline in the activities of the Supply Annex. In 1965 the Annex closed, and control of the Island passed to the Communication Station which had been expanding since 1960.

At present, the Headquarters is host to ten tenant activities, including the Coast Guard Boating Safety Team, General Services Administration, and Defense Logistics Agency; among others. There are 40 miles of operating

railroad and two USN switch engines, operated by the NAVCOMMSTA Public Works Department.

Approximately 400 acres are leased on a competitive bid to a local farmer for planting a variety of crops. There is a large wildlife preserve planted and cared for by Scouts of the 49'er Council of the Boy Scouts of America. The command won two DOD Conservation Awards in 1966 and 1967. The Boy Scouts also use a seven-acre wooded camp at Daggett Field and, throughout the year, a total of 1500 to 2000 scouts camp overnight here.

The station has several mast-type antennas, with an eight-story-tall tower, holding a sixty-foot disc antenna that links the station into a worldwide satellite communication system.

### CITY OF STOCKTON

Stockton, a modern city with a population of approximately 120,000, is the county seat for San Joaquin County, and is located in the extreme lower San Joaquin River Valley on the southeastern corner of the "Delta" near the only tidewater opening in the mountain wall surrounding the great interior valley of California. The immediate surrounding country is flat and near sea level with the rivers and canals kept under control by a system of earth levees.

Stockton's climate is characterized by hot, dry summer days and cool nights, mild winters and light precipitation, with 90 percent of the annual average precipitation falling in the winter half of the year. The Stockton area experiences heavy fog from about mid November to mid March due to low-lying marshy areas surrounding Stockton. During these months the area is covered at times with "tule" fog. This type of fog is unusually thick, low-lying and DANGEROUS. The problem is significant enough to have caused the establishment of a special OPERATION FOGBOUND program conducted by the California Highway Patrol. This program provides up-to-the-minute fog conditions on all major roads into and out of Stockton and the surrounding areas. Although Stockton is cooler than the more inland sections of the interior valleys during the summer months, daytime temperatures rise to 90 degrees or higher on an average of 22 days in July.

Temperatures of 100 degrees or more occur on an average of six days in July and 12 days during the entire summer. The humidity is very low (2%), however, during these hot afternoons. Under clear winter skies, night and early morning temperatures drop to near or below freezing, but on most of these frosty mornings the same clear skies result in afternoon temperatures in the fifties and sixties during the winter.

### EDUCATION

There are four fine undergraduate educational institutions in the Stockton area.

UNIVERSITY OF THE PACIFIC, California's first chartered university, was founded in 1851. In 1924 the campus was moved from San Jose to Stockton. Twelve schools and colleges with facilities in five locations in California and several foreign countries comprise the University of the Pacific. Central administration, four liberal arts colleges, four professional schools, and the graduate school are located on the Stockton Campus.

Although the campus features a wide range of student activities, UOP is particularly noted for excellence in drama, debate, musical organizations, and programs of student volunteer service.

Tuition and peripheral costs average \$6000-\$8000 per year.

The University offers a wide range of entertainment and cultural events throughout the academic year. Persons interested in attending should write or call the University of the Pacific, 3601 Pacific Avenue, Stockton, California 95204, or telephone (209) 946-2011.

SAN JOAQUIN DELTA COLLEGE is a public community college available to anyone who can profit from college level instruction. A high school diploma is not necessary to attend Delta's two-year academic program. Applicants must be 18 years of age or over.

More than 2,000 veterans enroll at Delta each semester and find such services as reading and writing laboratories, financial aids, and a tutorial center in addition to a modern, well equipped education operation.

The new Pacific Avenue campus features a five-center concept, with full-time students assigned to one particular center to personalize the education process.

Tuition is normally \$5 per semester for military personnel and dependents regardless of course load taken.

The college has a planetarium, recital hall, speech arts auditorium and other facilities involved in community service as well as direct instruction. Persons interested in attending San Joaquin Delta College (SJDC) should contact the office of the registrar, (209) 478-2011, or write to SJDC, 5151 Pacific Avenue, Stockton, California 95207.

COLUMBIA COLLEGE was founded in 1851. The home campus is located in Columbia, Missouri. An Extended Studies Program is offered at nearby Sharpe Army Depot in Lathrop, California. The college is accredited by the North Central Association of Colleges and Schools. It is a member of Project Ahead and of the Servicemen's Opportunity College (SOC) program.

Tuition is normally \$60 per credit hour for military personnel and dependents. A one-time-only enrollment of \$15 is charged to new Columbia College students.

Through Extended Studies Programs, the college offers Associate in Arts, Bachelor of Arts (with majors in Business Administration, English, History, Government, Psychology, or Administration of Justice) and Bachelor of Arts in Individual Studies. Personnel interested in Columbia College Extended Studies Program may write to Extended Studies Division, Columbia College, Columbia, Missouri 65201.

HUMPHREY'S COLLEGE is a small private accredited Junior College, currently conducting continuing education in higher Accounting and Business Administration, Engineering Technology (electronics or general engineering), and a four-year School of Law at night.

Tuition is \$36 per unit per quarter. For more information, write Office of Admission, 6650 Ingewood Avenue, Stockton, California 95207.

STOCKTON SCHOOL FOR ADULTS: High school diplomas may be earned at the Stockton School for Adults. Office is located at Edison High School, 1425 S. Center, Stockton, California, about three miles from the Naval Communication Station.

The school conducts classes in the evening or during the day, whichever suits the student. Tuition is free. Students must purchase their own books and supplies.

#### TRANSPORTATION TO STOCKTON

FROM TRAVIS AIR FORCE BASE: Local bus from Travis AFB to bus station in Fairfield (approximately five miles); then bus to Stockton. Take taxi from bus station to NAVCOMMSTA.

FROM SAN FRANCISCO INTERNATIONAL AIRPORT: Taxi to bus station in San Francisco, bus to Stockton, then taxi from bus station to NAVCOMMSTA.

OR

Plane from San Francisco International Airport to Stockton then taxi from air terminal to NAVCOMMSTA.

NOTE: Taxis are reimbursable expenses and you must have a receipt for all taxis where the fare is \$15 or more.

#### CHECK-IN PROCEDURES

When reporting aboard Naval Communication Station Stockton for duty Monday through Friday (0730-2200) or Saturday and Sunday (0730-1600), report to JOOD located at Building 17A (Main Gate). The JOOD will direct you to Military Personnel located in Building 217, room 111, where your orders will be endorsed. If you report after 2200 on weekdays or 1600 on weekends, the JOOD will endorse your orders. You will be required to report to



Military Personnel the next working day so that further check-in instructions may be issued. The following phone numbers may assist you in reporting aboard:

#### LIVING QUARTERS

FAMILY LIVING QUARTERS: Forrestal Village is the Navy public housing area located on Rough and Ready Island, and is available for personnel attached to NAVCOMMSTA Headquarters. Assignment to this housing is made by the Public Works Department Housing Office. Public bus transportation is provided to and from public schools. Children are picked up and returned to Forrestal Village. All the activities of the Island are within walking distance of the Village and the children are afforded adequate lawn and shaded play areas.

There are 40 two, three and four-bedroom units available for enlisted personnel. All maintenance is accomplished by Public Works Department. Units are unfurnished, except for stove and refrigerator. A very limited amount of used furniture is available for use if required. Arrangement of rooms is attractive, with large living and dining areas provided. Windows have Venetian blinds and fixtures for drapes. The bedrooms have wardrobe closets. Space and outlets are furnished for automatic washers. Houses are wired for 220 volts.

The enlisted section is composed of duplexes, triplexes, and quadriplexes. Four houses have carports. Assignments are made according to family size and on a first-come, first-served basis.

Personnel interested in obtaining housing should write the Housing Officer, Naval Communication Station, Stockton, California 95203 within five days of departure from their old duty station to have their name put on the waiting list. Full BAQ is charged for all units, which includes all utilities except telephone.

Most civilian rentals in Stockton are multiple family dwellings, duplexes, triplexes and apartments. Rent for single family dwellings is considered to be fairly high and occasionally difficult to locate.

TEMPORARY LIVING QUARTERS: Temporary Living Quarters (TLQ) are available to incoming personnel and their dependents for a limited period of occupancy, normally two weeks. They are designed to provide accommodations for families while they find permanent housing. No household pets or cooking are allowed.

Their central location offers access to eating and recreational facilities. TLQ facilities available are quite limited, and reservations should be made as far in advance as possible. A letter advising the date TLQ is desired and the number and ages of dependents should be sent to Personal Services Center, Naval Communication Station, Stockton, California 95203. The price is \$3 per day per room.

BEQ's. There are two BEQ's, which are divided into three wings: First and Second Class Petty Officers, Third Class and below, and enlisted women. These are modern, one-story buildings, well furnished, with game rooms, reading lounges, television rooms, and sunbathing areas provided for each. Each room is carpeted and provides sufficient quiet for watchstanders. All barracks are air conditioned.

BOQ. The BOQ is located in a two-story building and has rooms which are adequate for Lieutenants and below. Tennis courts are adjacent to the BOQ. CPO quarters are located in a newly renovated section at the BOQ building.

#### CLUB AND DINING FACILITIES

ENLISTED DINING FACILITY. The Enlisted Dining Facility is located in the BEQ and is considered to be among the finest in the Navy. The Dining Facility provides essential feeding for officers as well as enlisted personnel.

CONSOLIDATED MESS (OPEN). The CM (Open) has a large and handsomely appointed lounge, dining room, bar and summer veranda in the first floor of the BOQ building. Authorized patrons are E7 through O-10 and their civilian equivalents.

ENLISTED MESS (OPEN). The EM(O) is large, well furnished and contains a dining room, bar, a large party and dance room, and a game room. A wide variety of bands plays every Saturday night and Bingo is played every Thursday night. Authorized patrons are paygrades E1 through E6 and their civilian equivalents.

#### PERSONAL SERVICES

NAVY EXCHANGE. The Navy Exchange, which is a branch of the Alameda Regional Exchange System, is located in Building 217. It carries clothing and small store items, a fine line of clothing, domestics, camera and stereo equipment, household and personal care items, and appliances. The Courtesy Center in the Exchange offers refunds and exchanges, layaway sales, special orders, laundry and dry cleaning, watch repair, engraving, embossing, shoe repair, photo finishing, TV rental and repair, flowers by wire, heat transfers, calling cards and wedding invitations, and gift wrapping. Hours of operation are: Tuesday through Thursday 1000 - 1700; Friday 1000 - 1800; Saturday 0900 - 1530. Closed Sunday and Monday.

MINI MART. Primarily a convenience store, the Mini Mart stocks health and beauty aids, household supplies, essential food items, hardware and garden supplies, soft drinks and beer, pet food and pet supplies, stationery and periodicals, athletic goods, toys, and wheel goods. Hours of operation are: Sunday and Monday 1100 - 1530; Tuesday through Thursday 1000 - 1700; Friday 1000 - 1800; Saturday 0900 - 1530.

GAS STATION. The gas station is located immediately inside the island entrance. The station offers self service gasoline pumps, air,

and water. Also available are auto accessories, oil, additives, tires, and batteries. The station also sells cold beer and soft drinks. Services include carpet cleaning machine rentals and key duplication. The station does not have an auto service shop. Hours of operation are: Tuesday through Thursday 0900-1700; Friday 0900-1800; Saturday 0900 - 1530; closed on Sunday and Monday.

COMMISSARY. The Commissary Store, which is a branch of Oakland Commissary Region, is located on base approximately one-half mile from the main gate on the main entry road to the island. Hours of operation are: Tuesday through Thursday 1000 - 1700; Friday 1000 - 1800; and Saturday 0900 - 1500. Closed Sunday and Monday.

PACKAGE STORE. The package store is located across from the Commissary in Building 518. It offers a full line of bourbons, whiskeys, scotches, gin, and vodka. Also available is a good variety of wines and a selection of liqueurs and beer. Hours of operation are: Tuesday through Friday 1000 - 1700; Saturday 0900 - 1500; Sunday and Monday closed.

CREDIT UNION. The RARIN Federal Credit Union is located in Building 217A. Hours of operation are: Monday through Friday 1000-1630. Membership is available to all personnel attached to the Naval Communication Station Stockton.

NAVY RELIEF. The Navy Relief Society Branch Office is located in Building 17. Applications for Navy Relief assistance and layette service are handled by the Station Chaplain.

RED CROSS REPRESENTATIVE. Red Cross services may be obtained from the Stockton Chapter of the American Red Cross at 936 North Commerce Street, Stockton, California 95202. Phone (209) 466-6971.

CHAPEL AND CHURCH SERVICES. The Chaplain and Chapel facilities are available for all personnel attached to the command. The Chaplain's Office is located in Building 17. The Chapel schedule on Sunday is as follows:

1000 - Protestant Services

Catholic services are provided by the Stockton diocese on major religious occasions, including holy days of obligation in the base chapel.

LIBRARY. The station library is located in Building 17 and has over 2500 volumes of books, including reference books, fiction of various types, non-fiction, and current newspapers and magazines. Library can be used by military personnel and dependents. Hours of operation are from 0730-1600 Monday through Friday.

## MEDICAL AND DENTAL FACILITIES

MEDICAL. The station is served by a branch dispensary of the Navy Regional Medical Center Oakland. A civil service contract doctor provides regular medical treatment Monday - Friday 0730-1600. Referrals are also provided to NRMCOakland. Certain limited industrial health services are available to federal civilian employees. The CHAMPUS Program is available for use of civilian medical facilities due to the remoteness from other naval medical facilities.

Military Sick call hours are: 0730-0800 and 1230-1300 on normal working days. Hospital corps personnel are on duty at all other times for military emergencies. Ambulance service is available for use as deemed necessary by the station OOD or duty corpsman.

### Dependent routine medical treatment

Appointments at Naval Regional Medical Center Oakland. Dependents and retirees desiring appointments at NRMCOakland call the dispensary (944-0445). The dispensary makes appointments and notifies the person concerned of the time and date of the appointment.

Limited drugs, laboratory facilities and X-ray services are available to dependents and retired personnel. Drugs not available at the dispensary may be ordered from NRMCOakland.

DENTAL. Dental services are provided by a branch of the Navy Regional Dental Center, Treasure Island. All facilities are provided for active duty personnel. Military dependents are provided fluoride treatments only. Retired personnel are provided cleaning, examination and emergency treatment. All other treatment for retired is on a space available basis. Sick call is 0730-0830 and 1230-1300 on normal working days. For any emergencies that occur, contact the Duty Corpsman for the appropriate course of action.

EMERGENCIES OUTSIDE NORMAL WORKING HOURS. The following guidance is offered for emergency situations: Active duty personnel are encouraged to contact the dispensary by phone for guidance prior to proceeding to the medical facility. In that a medical officer is not in attendance at the dispensary, emergencies which are felt to require a doctor's assistance should be taken to the nearest civilian medical facility offering emergency treatment, i.e., Saint Joseph's, Dameron, or San Joaquin County Hospital. The Stockton Medical Clinic is also available for emergency treatment from 4 p.m. to 7 a.m. weekdays and offers 24-hour service on weekends. Going directly to such facilities for emergencies will prevent unnecessary delay and subsequent referral to a facility with a doctor in attendance. The telephone numbers and addresses of the closest emergency treatment facility should be readily available to you and your dependents. In many cases within the civilian community it is difficult to get private medical assistance if you do not have a family doctor. Establishing a family doctor at the earliest practicable time is a good idea.

## MORALE-WELFARE-RECREATION ACTIVITIES

Located in beautiful sunny Central California, only a few miles away from the cultural mecca of San Francisco and the majestic splendor of the State Capital in Sacramento, Rough and Ready Island offers a unique blend of natural environmental areas with modern recreational equipment. Named after "Old Rough & Ready," General Zachary Taylor, the island and its many recreational facilities are available for use by all military personnel and their families.

GOLF COURSE - A beautiful nine-hole course, club rental and cart rental available. ~~Weekday~~ and weekend rates. Open Monday 1200-Sunset; Tuesday through Sunday 0800-Sunset. For information, call 944-0442.

BOWLING LANES - A six-lane newly refurbished bowling alley. Open for operation Tuesday through Thursday 1600-2200; Friday 1600-2400; Saturday 1300-2400; and Sunday 1300-2200. The Bowling Alley will be closed on Mondays. Phone 944-0325.

MARINA - Available to rent at reasonable rates are 34 and 39 foot houseboats, great fun for parties on the river, and assorted sailboats, motor boats and ski boats, all equipped with Mercury engines.

DUCK POND. The Duck Pond is a man-made five-acre pond located on the west end of Rough and Ready Island. This area is designated exclusively as a hunting and fishing preserve.

HOBBY SHOP - The Hobby Shop is located in Building 617. It houses facilities for automotive repair, woodworking, ceramics, and lapidary. The hours of operation of the Hobby Shop are: Monday closed; Tuesday through Friday 0830-2100; Saturday 0900-1700; and Sunday 1300-2200. Phone 944-0307.

AUTO SHOP - The Auto Shop contains 16 stalls for automobile repair, a hydraulic grease rack, paint booth and drying room, valve grinding equipment, and tire balancing and repair equipment. The auto shop also houses a booth for heavy duty metal work, including welding and burning, and a small machine shop containing a hydraulic press, power hacksaws, and metal lathe. An Allen engine analyzer and a steam cleaner are also available.

CERAMICS SHOP - The Ceramic Shop offers a full line of greenware and ceramic supplies and sells ready-mix slip by the gallon. The shop stocks many different molds, and provides lockers for storing incomplete projects and personal gear. A part-time instructor also offers instruction in the art of ceramics. The hours of operation of the Ceramic Shop are:

Tuesday through Thursday	0930-1400
Tuesday evening	1700-2100
Saturday	1100-1600

GYMNASIUM - The Gymnasium and Gear Locker are located in Building 217A. The Gymnasium hours are Monday through Friday 1100-1900, Saturday and Sunday 1200-1700. Athletic gear and rental equipment are available. The Gymnasium houses a basketball court, handball court, body building room, and a sauna and shower facility for men and women. The body building room has complete weight lifting equipment, punching bags and a gymnastic horse.

GEAR LOCKER - Camping equipment, skiing, hunting and fishing equipment are available for checkout. A camper trailer and a pop-up canvas top trailer are also available. Nominal equipment rental charges and late charges are assessed to maintain equipment in good condition and to insure availability. Hours of operation of Gear Locker are:

Monday through Friday 1100-1900

HUNTING AND FISHING - Hunting is permitted on Rough and Ready Island weekdays from 1600 to sunset, weekends and holidays from sunrise to sunset during posted seasons. Hunting and fishing licenses are available from the Recreation Services Office.

MISCELLANEOUS - Other facilities include swimming pools, football and baseball playing fields, an ideal spot for picnics. For further information on these activities, or if you have any questions, contact the Recreation Services Department at 944-0582. We are here to make your stay here at Rough and Ready Island a pleasant one.

#### RECREATIONAL CLUBS

ROUGH AND READY ISLAND ROD AND GUN CLUB: Located on base, the Rod and Gun Club has a trap range and an archery range for the use of military and their dependents. The club is a member of the American Sportsman Association. Membership fees are \$12 per year. The club sponsors hunting and fishing trips periodically throughout the year. The fee for the trap range is \$1 for 25 clay pigeons and \$1.75 for 25 shotgun shells (12-gauge reload). Firearms are available for purchase at wholesale prices to members of the Rod and Gun Club.

DELTA VALLEY MODELERS CLUB: The Naval Communication Station provides 6.4 acres of land to the Delta Valley Modelers for use as a recreational airfield for Radio Controlled Model Airplanes. The club is AMA sanctioned and FCC approved. There is an initiation fee of \$75 and yearly dues of \$15 for civilian members. Active duty military members stationed in the area do not have to pay an initiation fee or yearly dues. The only requirement is that the active duty military member be a current member of the American Modelers Association and have an FCC license to fly R/C planes. Beginners are welcome, and instructions and advice are available.

SECTION THREE - NAVAL TELECOMMUNICATION CENTER BANGOR  
NAVAL SUBMARINE BASE, BANGOR, WASHINGTON

INTRODUCTION

NTCC Bangor is located 15 miles north of Bremerton, Washington. It is a tenant activity aboard the Naval Submarine Base, Bangor. NAVSUBASE Bangor is a 7,000-acre installation on the scenic Olympic Peninsula.

HISTORY

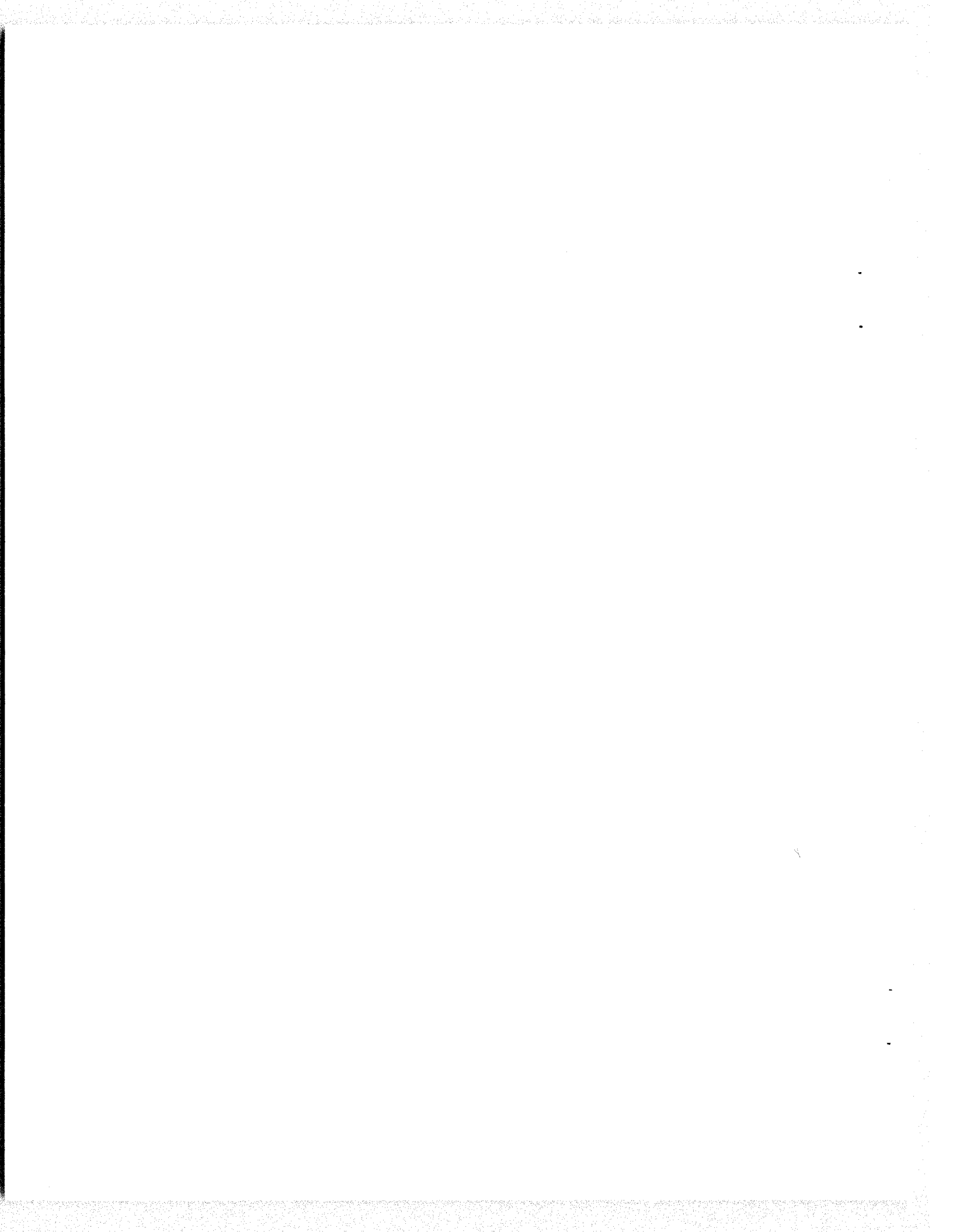
NTCC Bangor was established 1 October 1977. NTCC Bangor's primary mission is to support the commands of the Puget Sound area and specifically the Trident Submarine Program.

MAJOR SUPPORT FUNCTIONS

Because of Bangor's remoteness from headquarters Stockton, the Submarine Base provides NTCC Bangor personnel with all major support functions. These services include: military personnel; legal; postal; public affairs; educational services; supply and logistic support; household goods (PCS); medical; dental; special services; religious activities; BEQ/BOQ; family housing; consolidated clubs; Exchange; and Commissary.

LOCAL ACTIVITIES

Because of NTCC Bangor's location, activities abound for the outdoorsman. The fisherman will find salmon, cod, trout and steelheads. The hunter will find deer, elk, birds, ducks, and bear. The hiker has numerous trails available through the Olympic or Cascade Mountains. The skier is within two hours of most resorts. The mountain climber can challenge Mt. Rainier (14,400 feet). Additionally, the area supports all major league sports. Seattle is only an hour away by ferry and affords our personnel the opportunity to enjoy football, baseball, basketball, soccer, volleyball, and ice hockey. A tour of duty at NTCC Bangor truly allows a Navy person to experience duty in one of the finest places in America.





## SECTION FOUR - NAVAL RADIO TRANSMITTING FACILITY DIXON

### HISTORY

The industrial expansion of the Mare Island Navy Yard during World War II crowded the Mare Island Radio Transmitting Station to the degree that it was unable to expand its antenna system enough to meet the increased needs of the war. In 1944, to ease this situation, a new transmitting station was planned and land was purchased at Dixon, California.

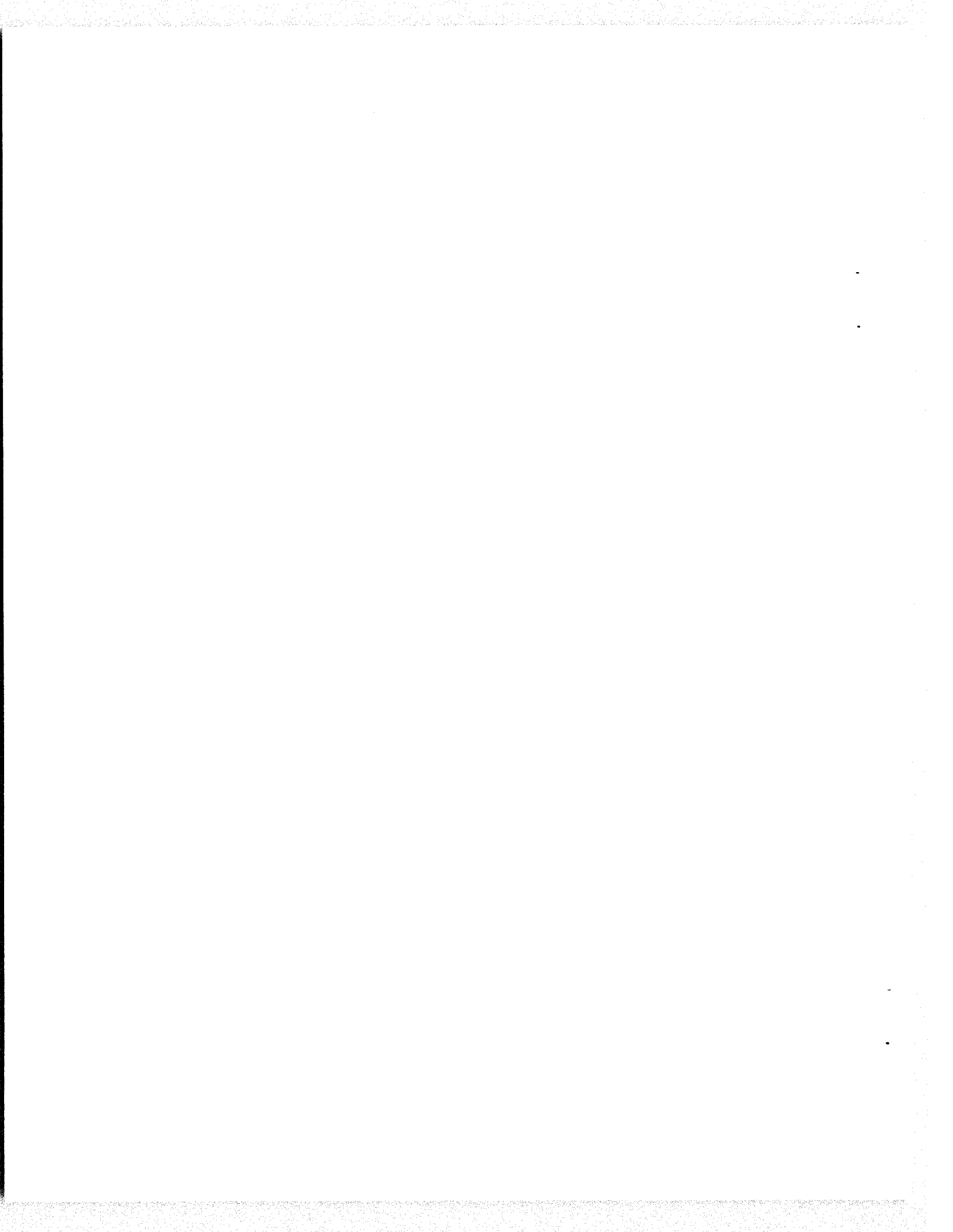
Construction was started on the new facility, but soaring costs and the post-war stand-down caused a halt to the building. In July 1946, the plans were revised and construction on a modified version of the original transmitting station was begun.

Finished in 1949, the Dixon site has taken the place of the old Mare Island Transmitting Station, which secured transmitters 18 November 1969 after 66 years of service to the fleet.

The Transmitter Facility, Dixon, provides services and equipment to many commands in the area, including NAS Lemoore, NAS Moffett Field, NAS Alameda, and Commander Fleet Air Wings Pacific.

The Radio Transmitting Facility, Dixon, California, a major component of the Naval Communication Station Stockton, is located on a 1,285-acre tract in the center of the vast farmland of the Sacramento Valley. The facility is 65 miles northwest of Stockton, 30 miles southwest of Sacramento, and 65 miles northeast of San Francisco. Dixon, with a population of approximately 6,000, is the closest town and is seven miles northwest of the facility. The Dixon climate is one of mild winters, warm summers with a daily zephyr off the Suisun Bay making nights cool. Prevailing winds are southwesterly about three to four knots. Yearly temperature averages a low of 44 degrees and a high of 74 degrees; temperature does reach 20 degrees and 110 degrees at the extremes, however. Yearly rainfall is 16.72 inches.

NRTF Dixon was placed under contract operation in April 1979.



SECTION FIVE - NAVAL RADIO RECEIVING FACILITY  
SKAGGS ISLAND SONOMA, CALIFORNIA

INTRODUCTION

Skaggs Island is a 4,390-acre island located at the north end of San Pablo Bay (the northern or upper half of San Francisco Bay), approximately fifty miles northeast of San Francisco, California. Surrounded by the growing communities of Vallejo, Napa, and Sonoma, one can find all the comforts for modern day living. Located at the southern gateway to both the Sonoma and Napa valleys, Skaggs Island provides a great starting point for wine country tours, hiking, biking, backpacking, and other outdoor activities. The Immediate Bay Area, less than 50 miles away, provides a number of professional athletic activities, including two football teams, two baseball teams, and one basketball team. Theaters, parks, zoos, and many other cultural activities are also readily available. Solano, Santa Rosa, and Napa Junior Colleges host a complete schedule of educational programs, available on in-service, VA, Tuition Aid, and other assistance plans. The surrounding area also abounds with excellent dining facilities for the gourmet.

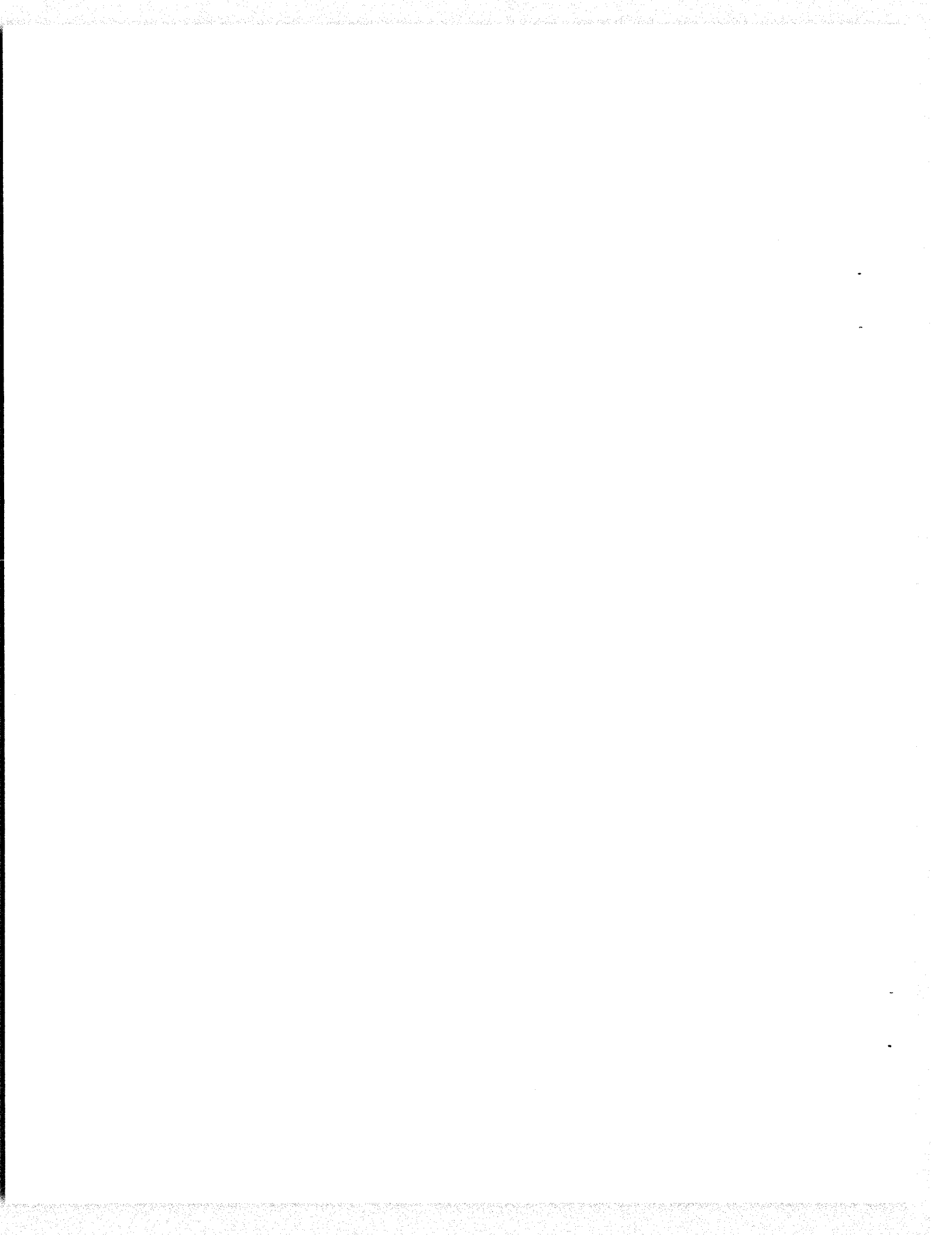
HISTORY

In 1940, the Navy was in search of a receiver site for the Bay Area. Following various land capability tests, the choice was narrowed to two locations: Grass Valley and Skaggs Island. Skaggs Island was preferable because of its close proximity to the San Francisco headquarters. At that time, negotiations between the Commander of Mare Island Naval Shipyard and the president of the Sonoma Land Company began, and in 1941 the Navy purchased the 3,000 acres from the land company for \$53 per acre. Construction began immediately on the Naval Radio Station, San Francisco, receivers unit.

Skaggs Island averages seven feet below sea level, protected from the flooding sloughs by the surrounding levees. During the early 1940's, seasonal rainfall and the impervious character of the soil resulted in fresh water pool flooding, which reduced the crop acreage by one-third to one-half. Because of the flooding, the original antenna field was built on barges. Improvements in land reclamation methods, including raising of the levees, digging and enlarging approximately 30 miles of drainage ditches, and installing pumps capable of moving large quantities of water, permit the cultivation of most of the island for farming. At present, 2,600 acres are being leased by the Navy to civilians for hay farming.

Security Group personnel have always been assigned to the Naval Radio Station Skaggs Island, and on 1 July 1962, the Command was redesignated as the Naval Security Group Activity Skaggs Island, with the Stockton Receiver Facility assuming the role of tenant.

NRRF Skaggs Island was placed under contract operation in April 1979.



## SECTION SIX - NAVAL TELECOMMUNICATIONS CENTER CONCORD

### NAVAL WEAPONS STATION, CONCORD, CALIFORNIA

#### MISSION

The Naval Telecommunication Center Concord is responsible for providing rapid, reliable and secure communications services to meet the requirements of Naval Weapons Station Concord; its tenant activities and assigned units.

#### HISTORY

Naval Telecommunication Center Concord became a part of the NAVCOMMSTA Stockton family in April 1978. NTCC Concord is presently a tenant command at the Naval Weapons Station. Naval Weapons Station Concord is the largest and most important military facility on the West Coast for trans-shipment of ammunition and other hazardous cargo. It also provides material and technical support for ammunition, weapons and weapon systems and is the homeport and logistic support agency for Pacific Fleet auxiliary ammunition ships used for replenishment of naval ships at sea. Located in Contra Costa County adjacent to the city of Concord, about 35 miles northeast of San Francisco; it covers 12,000 acres. This land area is necessary to support the many missions of the Station and to maintain a safe distance between explosive ordnance and populated areas.

The Station was established in 1942 as an annex to Naval Ammunition Depot, Mare Island; which was the first naval ordnance facility on the West Coast. It was established in 1850 by Commodore Farragut of Civil War fame, and constituted the humble beginnings of the present Weapons Station Concord. Today the station is an independent command reporting to the Naval Sea Systems Command, Washington, DC. Area coordination is under the Commandant of the Eleventh Naval District.

The Station's concern for ecology and conservation has resulted in the preservation of a huge green belt for Contra Costa County. It is a designated wild life preserve where deer, Tule elk, golden eagles, quail, pheasants, fox and other birds and animals live unmolested by man. Much of the acreage is leased for grazing to provide controlled fire breaks. Another ecology project is the experimental tree farm operated by the U. S. Department of Agriculture which has made significant contributions to the local flora.

Weapons Station Concord is within commuting distance of many naval activities in the Bay Area. These include Naval Support Activity, Treasure Island; Naval Air Station, Moffett Field; Naval Air Station, Alameda; Naval Supply Center, Oakland; Mare Island Naval Shipyard, Vallejo; and Naval Regional Medical Center, Oakland.

WPNSTA Concord's mission is to provide material and technical support for ammunition/assigned weapons and weapons systems; maintain and operate an explosive ordnance outloading/trans-shipment facility; provide homeport

services to Pacific Fleet ammunition ships assigned; and perform additional tasks as directed by COMNAVSEASYSKOM.

### CITY OF CONCORD

Concord, the largest city in Contra Costa County, lies in the Diablo Valley, one of the more beautiful regions of the San Francisco Bay Area. Gently rolling hills and forests, accented by the rising slopes of Mt. Diablo, provide a protective buffer from the faster paced metropolitan cities of Oakland and San Francisco. The barrier is not so much physical as it is psychological; modern freeways and the Bay Area Rapid Transit system put Concord only minutes away from the many communities that make up the San Francisco Bay Area, yet Concord is referred to more aptly as a city in the country. It does not share an identity with other Bay Area cities as much as it projects its own.

A commuter city, yes; Concord is the northeastern terminal for the revolutionary BART system, the coming of which brought profound changes in the area's economy, development and future. About one-half of the city's wage earners commute outside city limits. But BART is bringing people into Concord in increasing numbers as well, in the form of new business, new industry, and new opportunities.

More than anything else, Concord is the place to enjoy an enriched, satisfying lifestyle. Activities and events abound for all ages. The new Concord Pavilion has brought the city new recognition as a flourishing cultural center. The open countryside, mountains, and inland waterways are at Concord's doorstep. The air is clean and clear and is easy to breathe.

It is these factors--the "small town" atmosphere with all the amenities of modern-day living--that have made Concord an especially desirable place in which to live.

### LIVING QUARTERS

FAMILY QUARTERS: Limited officers and enlisted. There are 34 officer houses located on base; enlisted quarters consist of 16 four-bedroom and 68 three-bedroom units located two and one-half miles from the Naval Weapons Station Concord.

BACHELOR ENLISTED QUARTERS: Enlisted Navy, Coast Guard, and Marine Corps personnel living aboard WPNSTA Concord are berthed in 186, 187, E-96, and IA-10. Navy and Coast Guard BEQ Office is in Building 185.

### PERSONAL SERVICES

NAVY EXCHANGE: Located in Building IA-10. Clothing, self-service section, sundry household articles, and a limited number of food items (dairy products, bread, canned food, etc.).

SERVICE STATION. The service station is located adjacent to Building IA-5.

NAVCON FEDERAL CREDIT UNION. Retired military and active duty military personnel attached to WPNSTA Concord, and homeported AE's are eligible for membership. A new office, the Mt. Diablo Federal Credit Union, has been established at 2290 Diamond Boulevard, Concord.

RELIGIOUS SERVICES. Services for all faiths are under the direction of Navy Chaplains. The chapel is in Building IA-30.

MEDICAL AND DENTAL FACILITIES

MEDICAL. The primary mission of the clinic is to provide health services to all authorized personnel. Services are available in several specialized areas. Military sick call is limited to the hours of 0730-0900 and 1300-1430 Monday-Friday; emergencies will be seen any time.

DENTAL. All phases of authorized dental treatment are rendered to active duty military personnel. Dental sick call is held at 0730-0830 and 1300-1400 on week days.

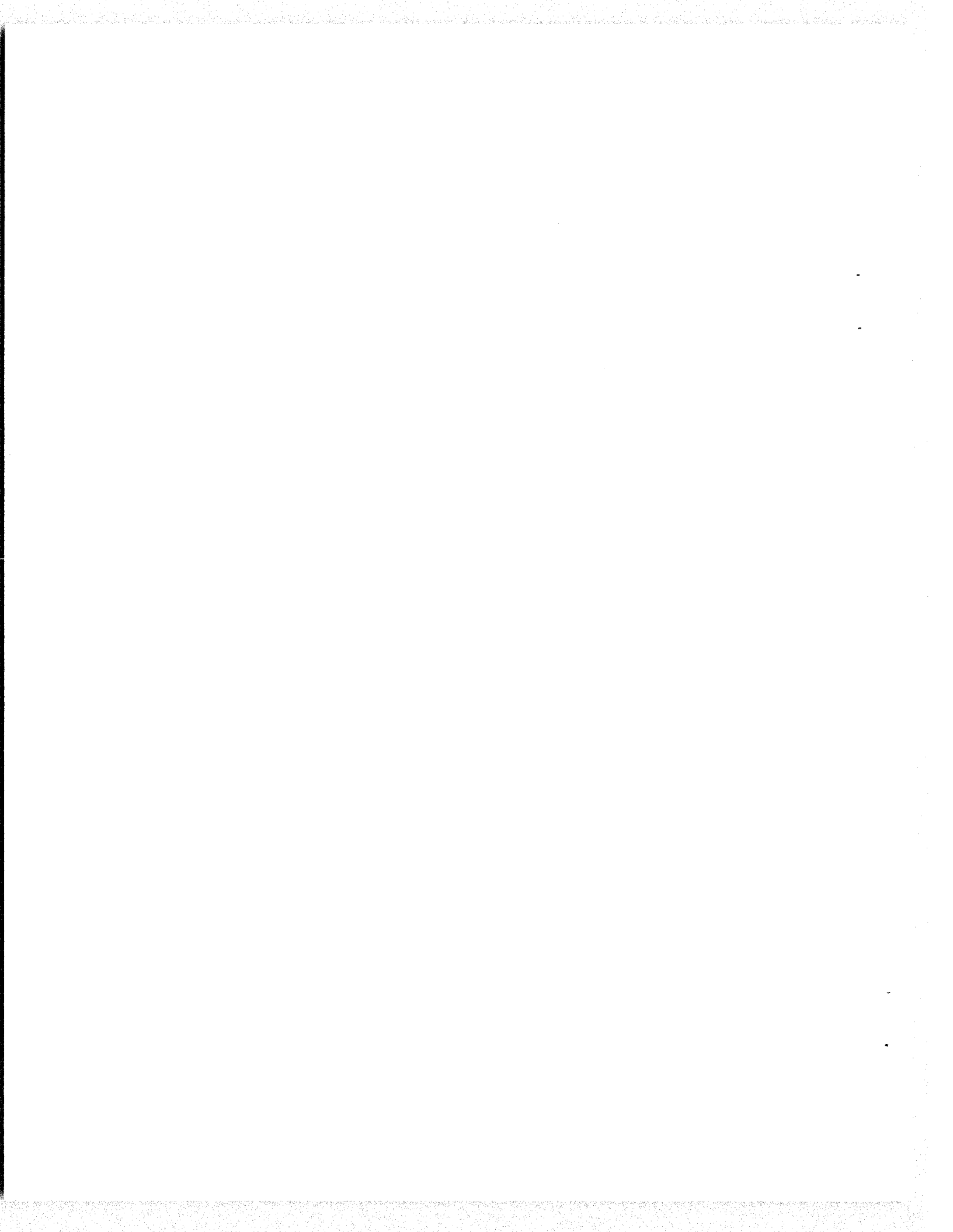

## SECTION SEVEN - NAVAL TELECOMMUNICATION CENTER

### MARE ISLAND

#### INTRODUCTION

General Mariano Guadalupe Vallejo, while on a mapping expedition with a company of Mexican cavalry troops, was fording Carquinez Straits when one of his favorite horses, a white mare, became detached from the group and was carried away by the swift current of the Sacramento River. Ultimately the horse struggled ashore on Isla Plana, where she was subsequently found. The General promptly changed the name of the site of the future naval shipyard to "Isla de la Yegua" - Mare Island.

#### HISTORY

Naval Telecommunication Center Mare Island became a part of the NAVCOMMSTA Stockton family on 1 July 1975. NTPCC Mare Island is located in Building 47 and is presently a tenant command of Naval Support Activity, Mare Island, California. The Naval Support Activity was established by the Secretary of the Navy in July 1971 to provide appropriate logistic support for activities and commands as assigned by the Chief of Naval Operations.

#### PERSONAL SERVICES

In the areas of health, welfare, and morale, the Naval Support Activity provides legal assistance; conducts religious services; furnishes berthing accommodations; feeds an average of 900 enlisted personnel a day and 40 officer personnel; furnishes housing information to applicants; and acts as host to various district, regional, and service-wide sports tournaments and events.

The Naval Support Activity provides such facilities as Officers, CPO, and Enlisted Clubs; clothing services; commissary store and an exchange complex consisting of a new main exchange, barber shops, branch retail stores, cafeterias, snack bars, tailor shops, automobile service station, dry cleaning shop, automatic vending machines and special order services.

In addition to providing services for health, welfare and morale of Navy personnel, the Naval Support Activity performs an equally essential function in exercising internal and external security control for all activities on Mare Island. This includes fire protection, with three fire stations; police protection; Shore Patrol support, and acts as liaison between naval and civilian police and provides legal assistance in connection with the Shore Patrol.

The Naval Support Activity's Operations Department provides tug and harbor services in the North Bay area.

## RECREATIONAL FACILITIES

The Special Services Department provides a wide variety of leisure time activities such as a nine-hole golf course (ceramics, auto, photography, and woodworking facilities); a Day Care Center; library, bowling alley, tennis courts, baseball and picnic areas, movies and a multitude of other activities. The Mare's Tale, the station newspaper, serves as an internal communications medium on the island.

## HOUSING

The Housing Office is located in Building 730 (next to Morton Field). There are 481 units of adequate public quarters on base available for assignment to eligible personnel on a "first-come, first-served" basis by date of housing application. Personnel on ships homeported here or under construction are eligible for assignment to public quarters on an equal basis with shore stationed personnel. Requests for public quarters should be addressed to the Commanding Officer, Naval Support Activity, Mare Island, Vallejo, California 94592, Attn: Housing Division, Code 82.

## TRANSIENT FAMILY HOUSING

Transient Family Housing is available only to forces afloat personnel; however, there are 384 substandard housing units located off base in Vallejo, within one mile of Mare Island. These are relatively easy to get into, are available to all grades and ranks through Lieutenant and require only 75% of enlisted BAQ.

All requests for substandard housing quarters should be made through the Housing Office.

## RELIGIOUS ACTIVITIES

The Chaplain's office is located on the second deck of Rodman Center. Regular Sunday services are conducted at St. Peter's Chapel and Estrellita del Mar. Holy Communion for Protestants is celebrated on the first Sunday of the month. Catholic weekday Masses are celebrated at St. Peter's Chapel. Confessions for Catholics are heard before Mass or at the Chaplain's office. Religious education in Building 733 includes Sunday School for Protestants from ages four through adulthood and CCD for children from pre-school through eighth grade. Catholic baptisms and adult instructions are by appointment. The Protestant choir rehearses every Wednesday evening at St. Peter's. There is a wide variety of chapel activities which provide ample opportunity for participation.

## COMMISSARY

The Commissary is located at the north end of Mare Island. The facilities were originally constructed in 1942 but continued remodeling and enlarging provides an adequate facility for the number of patrons served. However, on payday and the Saturday following payday, shopping is extremely congested. To avoid congestion, shop the off payday week.

## NAVY EXCHANGE

The Main Store is a modern facility which carries a full line of clothing, domestics, gifts, camera and stereo equipment, household and personal care items, and small appliances. The same building houses a Special Order Desk, Check Cashing facility, and Personalized Services Center. The nearby Town and Country Center has a number of shops for your convenience. The Country Store (Navy Exchange portion) sells sporting goods, hardware items, toys, home improvement items, beverages, and some food items, garden, pool and barbecue supplies. Other service shops in this building are: the Laundry and Dry Cleaning Center, the Optical Shop, Watch Repair, Baskin-Robbins Ice Cream, Snack Bar, Uniform Shop, and Barber Shop. The Service Center sells beverages, rents cars, TV's, washers, dryers, small refrigerators, rug shampooers, vacuum cleaners, sewing machines, typewriters, and projectors. Radio and TV repairs can also be handled here, as well as do-it-yourself tube testing and replacement. The Service Center is located at the corner of Cedar and E Streets near the Bank of America. The Auto Service Center was recently built at Railroad and K Streets, near the north gate. Besides selling gasoline, it also has a large sales area where car accessories, parts, and automotive supplies can be purchased. Additionally, there are six service bays to accommodate a wide range of maintenance and repair work. Finally, there is a Convenience Store located off-base in the substandard housing area (Roosevelt Terrace). This store is open daily and has many groceries and household items.

## MEDICAL

The Dispensary is located in Building H-73 at the south end of Cedar Avenue. Clinics located in the Dispensary render outpatient medical service to eligible dependent and retired personnel of the Armed Forces on an appointment only basis during the following hours: Monday through Friday 0930 to 1200 and 1430 to 1600, except Thursday afternoon. However, because of the limited number of doctors available, care may be curtailed at any time. When appointments are available, they may be made by calling 646-2384. Whenever an appointment cannot be kept, please notify the appointment desk as far in advance as possible. Inoculations are given from 0800 to 1100 and from 1300 to 1530, except Thursday afternoon. When full hospital facilities are required, active duty military are referred to the Naval Regional Medical Center, Oakland, California. Prenatal and obstetric care are not provided by the Dispensary, however, the diagnosis is made and pregnant women are referred to Travis AFB.

## DENTAL

The Branch Dental Clinic is located in Building 764 on Sargo Avenue at Thirteenth Street. Complete dental services are available including dental prosthesis. Routine, definitive, or elective dental treatment requiring services of a dentist are not authorized for dependents. However, as workload permits, the Facility is able to provide dental X-rays on written request of a civilian dentist, oral hygiene instruction,

and stannous fluoride treatment by appointment. No appointment is necessary for oral examination for school admission or physical qualification or for emergency treatment. All regularly scheduled dental appointments are considered official and must be kept or cancelled 24 hours in advance through the Dental Facility.

#### TEMPORARY LIVING QUARTERS

Temporary living quarters are not available at Mare Island. The Housing Referral Office has a list of suitable hotels and motels located in Vallejo (Temporary Living Allowance not authorized). Temporary Living Quarters are available at Travis AFB (approximately 20 miles distant from Mare Island) on a first-come, first-served basis. Additionally, temporary trailer court space is available at Travis at the rate of \$2 per day. Interested personnel having campers/trailers/RV's may phone AUTOVCN 837-2488 for details.

## SECTION EIGHT -- NAVAL TELECOMMUNICATION CENTER OAKLAND

### INTRODUCTION

The Naval Telecommunication Center Oakland is responsible for providing reliable, rapid and secure communication service to meet the requirements of the tenant commands and components of Naval Supply Center Oakland, activities, and assigned ships (while berthed in the surrounding ports) of San Francisco; Oakland; and Treasure Island, California. Naval Telecommunication Center Oakland is located in Building 311, 3rd deck, Naval Supply Center, Oakland, California.

### HISTORY

The Naval Telecommunication Center Oakland came into being on 1 October 1972 as the result of combining the communication facilities of Commander, Military Sealift Command Pacific and Commanding Officer, Naval Supply Center Oakland. The Naval Telecommunication Center Oakland is a component of Naval Communication Station Stockton, Stockton, California. On 7 January 1979, Naval Telecommunication Center Oakland and Naval Telecommunication Center Treasure Island were consolidated. Therefore, all commands, components, and activities that were served by Naval Telecommunication Center Treasure Island are now the responsibility of the Naval Telecommunication Center Oakland.

### FACILITIES

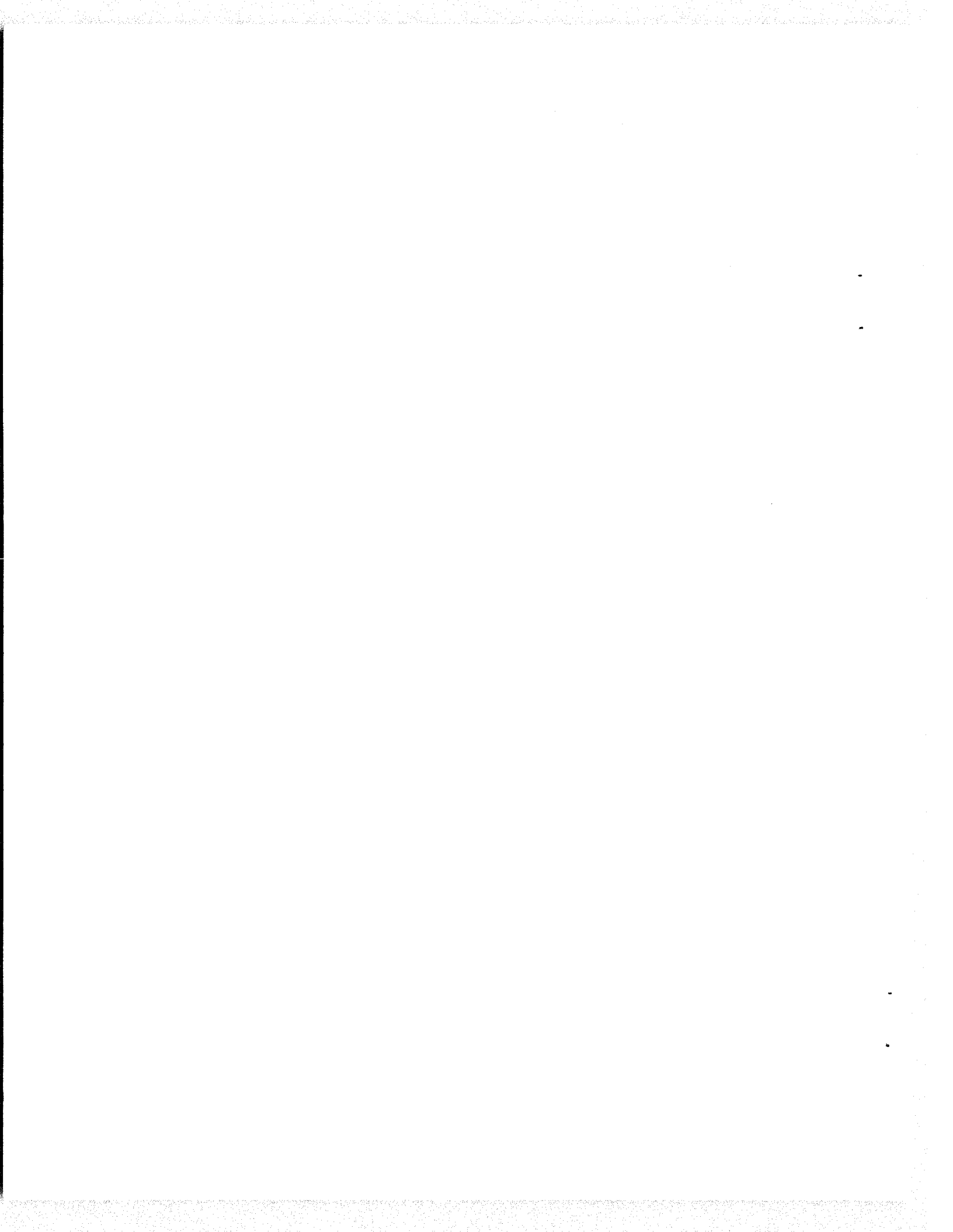
There are no facilities, i.e., government messing, berthing or family housing, located at Naval Supply Center Oakland. The nearest facilities are located at Treasure Island, approximately seven miles distant. However, there are other facilities in the Bay Area located at a greater distance from Naval Telecommunication Center Oakland.

### DISPENSARY

Military sick call 0730-0900, 1300-1430; emergencies at any time. After working hours there is a Corpsman on duty for routine illness. If the illness is beyond his capability, patients will be sent to the Naval Regional Medical Center Oakland (Oak Knoll). No dependents are seen at the NSC dispensary. However, the Army has a dispensary located at the Oakland Army Base which is adjacent to NSC. They do provide services for dependents.

### DENTAL

Dental services are provided at NSC Oakland by a branch of the Regional Dental Center, San Francisco, located at Treasure Island. All facilities are provided for active duty personnel. Sick call is 0715-0800, 1230-1330, Monday through Friday.



## SECTION NINE - NAVAL TELECOMMUNICATION CENTER

### ALAMEDA

#### INTRODUCTION

The Naval Telecommunication Center Alameda is responsible for providing rapid, reliable and secure communications services to meet the requirements of NAS Alameda, its tenant activities, and assigned units. The Center also serves as an Armed Forces Courier Service transfer point.

#### HISTORY

The Naval Air Station Alameda was commissioned on 1 November 1940 and was turned over to a staff of 200 civilian employees and a small complement of naval personnel.

At the moment of the attack on Pearl Harbor, Naval Air Station Alameda's buildings were still gaunt steel frameworks and the five 5,000-foot runways were only partially completed. In spite of this, the rest of the nation and air station personnel went to work in earnest to support the fighting forces. The result was fast and efficient production. As the "Aviation gateway to the Pacific" in World War II, facilities were built almost overnight; personnel were hired and trained and military men and supplies were funnelled out to the far reaches of the Pacific in dizzying numbers.

It was from NAS Alameda that the famed General Jimmy Doolittle and his B-25 Mitchell bombers were loaded aboard the aircraft carrier USS HORNET prior to their takeoff on the first attack of the war on the Japanese homeland - the hard-fought Battle of Tokyo.

Then, suddenly, the war was over. Japan had surrendered. For a station that had known only the strains of graveyard shifts, emergency "make-do" methods, car-pools, and rationed cigarettes, peace was an unknown quantity. The Station had to learn to adjust to new conditions. Under the program for peace, NAS Alameda placed equal emphasis on all phases of its primary mission - that of providing facilities and support for fleet aviation activities. This included overhaul and repair of aircraft for the Fleet, supply of all kinds of aircraft and equipment; the berthing and fueling of large ships; and training facilities for military personnel.

For the Viet-Nam crisis, the Station once again provided massive support for the Pacific Fleet. Every effort is made to carry out the Station's mission and tasks effectively and efficiently in support of Navy ships, aircraft, equipment and personnel ashore and aboard.

#### EDUCATION

There is an excellent on-board opportunity to gain a Master's Degree in Management from the University of Southern California; a B.A. Degree

from Golden Gate University in Business; or a B. A. Degree from Chapman College in Social Sciences. Alameda College, located about one-half mile from the East Gate, is a two-year community college.

### LIVING QUARTERS

FAMILY LIVING QUARTERS. Assignment of housing is restricted to members of the Armed Forces accompanied by their dependents who are attached to the Naval Air Station Alameda, Naval Supply Center Oakland, Naval Regional Medical Center Oakland, ships, units, and on-station tenants of other services within the East Bay geographical area, homeported or home-based within the area bounded on the north by Carquinez Straits, on the west by San Francisco and San Pablo Bays, on the east by the Oakland Hills, including the City of Hayward on the south, all of which have been authorized by the Eleventh Naval District. All military personnel, both men and women with accompanying dependents, in pay grade E-4 with over four years of service and senior, and those in pay grade E-4 with two years active duty who receive PCS orders are eligible to apply for family housing. Assignment of eligible personnel will be made on the basis of precedence on the waiting list, availability of a unit suitable to the rank of the applicant, and suitable to the size and composition of the family. No assignments will be made to personnel contemplating occupancy of less than six months. Fleet and shore-based personnel are given equal opportunity in assignment to housing. Personnel eligible for housing may apply to any or all Housing Authorities within the East Bay geographic area regardless of location of command, provided the commuting distance is reasonable, normally one hour in peak commuting hours. Applicants may be placed on waiting lists only in one geographical area.

A number of two to four bedroom quarters is available at Hamilton Air Force Base for eligible Navy families, currently with a shorter waiting period than for the quarters at NAS Alameda. Information on the method for applying for these quarters can be obtained from the Housing Referral Office, telephone 2065, or the Hamilton Air Force Base Housing Manager, 838-3824/3825.

TEMPORARY LIVING QUARTERS. The Navy Lodge, NAS Alameda, consists of 70 units which contain two double beds, plus a single bed, private bath and a kitchenette. Price is \$13 per day. Advance reservations are strongly recommended, although rooms may at times be available on a "walk-in" basis. Reservations may be requested in writing from the Navy Lodge, Building 531, NAS Alameda, California 94501, or by telephoning (415) 523-4917.

BEQ. If you are going to be attached to NAS Alameda or one of the tenant commands, you are entitled to berthing aboard NAS Alameda IF:

1. YOU ARE SINGLE, or
2. YOU ARE LEGALLY SEPARATED, or
3. YOU ARE MARRIED BUT YOUR FAMILY WILL BE LIVING MORE THAN 50 MILES FROM NAS ALAMEDA.



If you fit into one of the above categories and would like to reserve a room in advance, send a memo to BEQ Manager, Building #4, Wing #15, Naval Air Station, Alameda, California 94501 with the following information:

1. NAME AND RATE.
2. COMMAND TO WHICH YOU WILL BE ATTACHED (NTCC ALAMEDA).

Reservations cannot be made without all of the above information.

#### CLUBS AND DINING FACILITIES

NAS Alameda has an Enlisted General Mess, an Enlisted Mess (Open), an Enlisted Mess (Open) Annex, a CPO Club, a Commissioned Officers' Mess (Open), and a Commissioned Officers' Mess (Closed).

#### PERSONAL SERVICES

NAVY EXCHANGE. The Navy Exchange Alameda has a complete line of military and civilian attire, household supplies, sundries, and offers convenient service to military personnel and their families at its newly remodeled shopping complex. The present Clothing and Small Stores and Uniform Shop has been incorporated into a Naval Uniform Center located in the main retail store. In addition to the main retail store, the Navy Exchange Main Complex also provides a tailor shop, barber shop, beauty shop, laundry/dry cleaning outlet, optical shop, watch repair shop, flower shop, portrait studio, personalized services center, check cashing service, Baskin-Robbins ice cream parlor, and a cafeteria.

The Mini Mart is located adjacent to the mail complex, carrying hardware, garden supplies, grocery selections, auto supplies, and assorted beverages. The Exchange service station, garage, and auto parts store are adjacent to the main complex in Building 459.

COMMISSARY STORE. The Commissary Sales Store is located in Building 152 on the Station, midway between the East Gate and the Main Gate. Commissary privileges are limited to active duty and retired personnel and their dependents. The NAS Alameda Commissary Store features a wide selection of fruits and vegetables, fresh meats, and other food products.

CREDIT UNION. The NAS Alameda Federal Credit Union is open to civilian employees and military personnel assigned to NAS Alameda and tenant activities. Retired military personnel using base facilities are also eligible for membership. The Credit Union offers a convenient place to save money and pays a high return on savings. Loans are available at low interest rates.

NAVY RELIEF. The Navy Relief Office is located in Building 135 and is open from 9 a.m. to 4 p.m., Monday through Friday. The purpose of the Navy Relief Society is to collect and hold funds and to use them for aid to Navy families. Services provided are:

1. Financial assistance given in the form of a loan without interest; an outright gift; or a combination of the two.
2. Financial counseling with regard to budgeting.
3. Visiting Nurses Program, which provides assistance for dependents who need guidance and instruction in learning to care for newborn infants.
4. Layettes furnished to those Navy and Marine Corps families when the need exists. Expectant mothers in need of baby clothes may apply for layettes at the Navy Relief Society Office.
5. The Navy Relief Thrift Shop, Building 130, open from 9:30 a.m. to 12:30 p.m.; Tuesday through Friday, provides an outlet where serviceable clothing and household articles are sold at minimum prices.
6. A Special Needs Program in which trained interviewers are available to discuss and assist with any and all problems. Every effort is made to insure that each individual gets the best and most constructive help for his individual problem.

AMERICAN RED CROSS. The Red Cross office is located on the second floor, Building 135. All active duty servicemen and their legal dependents are eligible for Red Cross service. Retired military personnel are eligible for reporting and counselling service only.

1. Verification of emergency leave and emergency leave extensions.
2. Financial assistance for servicemen granted emergency leave.
3. Counselling regarding the proper procedure for submitting an application for a hardship discharge or humanitarian reassignment.
4. Home condition reports for the Commanding Officer, serviceman and their dependent.
5. Counselling regarding personal and family problems.
6. Emergency financial assistance for servicemen and their dependents who experience unforeseen emergencies.

RELIGIOUS SERVICES. Services for all faiths are under the direction of Navy Chaplains whose offices are in Building 18. The Chapel is on

Avenue "A" and Third Street: All military personnel, their dependents, friends and relatives are welcome to all religious services and special activities conducted by the Station Chapel.

Nursery care is available without charge in the Station Nursery, Building 135, during the Sunday Services.

Baptisms, weddings, and special classes are available by calling 869-4386. All special days and seasons are celebrated and special notices announce the times and dates. Provision for services of other faiths is made with local churches.

#### MEDICAL AND DENTAL FACILITIES

MEDICAL: The Alameda Branch Clinic is a complete modern facility operated by the Naval Regional Medical Center, Oakland. Military personnel will only be treated when in a clean uniform of the day, except for medical emergencies. All dependents and retired personnel being seen in any clinic at the dispensary must have an appointment, with the exception of emergencies. All dependent personnel over 12 years of age, and female active duty personnel are seen in the Adult Medicine Clinic. Priorities of being seen are as follows:

- 1: Medical emergencies.
- 2: Active duty female personnel.
- 3: All other patients with appointments.

All dependents 12 years old and under are seen in the Pediatric Clinic by physicians and nurse practitioners specially trained in pediatric care. Well Baby Clinic is held on Friday mornings from 8 a.m. to 12 noon. Appointments may be given following your baby's examination. Well Baby checkups are given at two weeks, two months, four months, six months, and twelve months.

Orthopedic, Podiatry, Gynecology, Wart and ENT Clinics are also held weekly. These clinics are on an appointment basis only and require a consultation from a General Medical Officer for all but Gynecology. After normal work hours/days the clinic is staffed by paramedics only. Patients 12 years and under and all those with a significant medical complaint are referred to the Naval Regional Medical Center, Oakland (Oak Knoll Naval Hospital) to be seen by a Medical Officer. Transportation will be provided for actual life-endangering emergencies only.

DENTAL: The Dental Annex is a facility of the Naval Regional Dental Center, San Francisco, California. The Annex Dental Facility provides complete dental services for all military personnel based at NAS Alameda. It has an extensive preventive dentistry program for military personnel and extends this program on a year-round basis for dependent children ages 5 to 18 years of age.

## RECREATIONAL FACILITIES

GYMNASIUM AND GEAR LOCKER: The gymnasium offers numerous athletic and recreational activities including basketball, volleyball, handball and racketball, badminton, and a weight and exercise room. A complete schedule of intramural and varsity sports is available for men and women. There are also tennis courts, softball fields, a football field, and numerous areas for jogging.

Whether you're headed for the mountains or the sea shore, you'll want to stop by the Camping Gear Issue to check out the various items required. You'll be able to rent tents, sleeping bags, fishing tackle, shotguns, snow skis, toboggans, and much more.

HOBBY SHOP: The craft center offers ceramics, woodworking, boat building, upholstery, lapidary, metal working, and photography. Assorted classes are available during the year to help you learn a new craft.

Your car can get a complete overhaul at the Hobby Shop Garage. You can do everything from painting to body work to refining the brakes and doing a tuneup. A hydraulic lift, battery recharger, engine analyzer, and engine steam cleaner are available.

BOWLING LANES: There are 24 modern bowling lanes equipped with automatic pin setting machines, telescopes, and automatic foul line lights. Open play, league bowling, youth leagues, and lessons are available. There is also a resale pro shop for all your bowling needs.

THEATER: The NAS Cinema offers major motion pictures twice nightly, except on Saturdays. The first movie begins at 7 p.m. and a different movie is shown approximately 15 minutes after the first movie is completed. A children's matinee is shown on Saturdays at 1 p.m.

GOLF COURSE: Farrington Fairways is located east of the Main Gate. This six-hole par 18 pitch and putt course is open daily and there is no charge to play. Golf clubs are available at the Camping Gear Issue.

BOAT MARINA: The Marina offers wet and dry slip berthing, boat and trailer rentals, sailboats and sailing instruction, and a picnic facility.

SWIMMING: The huge olympic size swimming pool, located at the gymnasium, is equipped with a one-meter fiberglass diving board and an adjacent sunbathing patio. Swimming lessons for youth and adults are offered year round. Qualified lifeguards are always on duty.

## RECREATIONAL CLUBS

AERO CLUB: Flight instruction and recreation flying in eight club-owned aircraft. Active duty military personnel and dependents, full-time civilian employees of DOD, and reserve military personnel are eligible for membership.

SECTION TEN - NAVAL TELECOMMUNICATION CENTER  
MOFFETT FIELD

MISSION

The Naval Telecommunication Center provides local over-the-counter message service for narrative and data card traffic processed by the DOD AUTODIN System. Tactical communications are provided for Commander, Patrol Wings Pacific; in support of several P-3 Orion Squadrons based at NAS Moffett Field.

HISTORY

Moffett Field was established over four decades ago as the home base for the nation's mightiest airship, the USS MACON. Originally established as Sunnyvale Naval Air Station in April 1933, the base was renamed in 1942 in honor of RADM William A. Moffett, who lost his life aboard the airship USS AKRON just eight days before Sunnyvale Naval Air Station was commissioned.

Today, NAS Moffett Field is the headquarters for the Navy's landbased patrol planes covering the entire Pacific, and can be easily recognized by "Hangar One," the huge airstrip hangar which was completed in 1933. This magnificent architectural feature is one of Santa Clara Valley's outstanding landmarks today. This massive structure is 1,138 feet long, 308 feet wide and 198 feet high. In the early 1950's, Hangar One was named a Naval Historical Monument.

Moffett Field is located in Mountain View, California, approximately ten miles northwest of San Jose and 35 miles southeast of San Francisco. The Naval Telecommunication Center is located in Building 300 on the opposite side of the airfield from the main base complex.

The Bay Area climate is generally mild and very pleasant, with temperatures ranging from an average high of 75 degrees in the summer to an average low of 47 degrees in the winter. The summer months are generally warm and dry, with the area receiving only a negligible amount of the annual 13.3 inches of rainfall.

LIVING QUARTERS

FAMILY LIVING QUARTERS: As in most of the Bay Area, the housing situation is critical. Applications for housing are processed through the Housing Office located just outside the Main Gate. Government housing is subject to a "waiting list" which starts on the date of application. Applicants for a two-bedroom unit may have to wait for an average of 18-20 months before they can move in. Three-bedroom units average 3-6 months. The number of dependents, and their ages, establishes the criteria for housing determination. Co-located with the Housing Office is the Housing Referral Office which offers listings of local apartment and

house rentals. Vacancies in the local civilian community are very scarce. The average apartment rents for \$190-\$500 per month, while single family dwellings and duplexes rent for \$375-\$600 per month. Very few apartments will accept children or pets and those that do often require a \$50-\$250 deposit. Since there is no Navy Lodge at Moffett Field, personnel are advised, if at all possible, to visit the locality before moving their families here so they may look for adequate housing.

BEQ: There are seven old and two new barracks on base which berth Squadron personnel and E-1 to E-6. The E-7 to E-9 personnel have a separate wing of the new barracks and the enlisted women have three floors of one of the new barracks. The new barracks are divided into modules of four rooms each with a common lounge. The old barracks have a central pool room and a central TV lounge on the first floor of each barracks. Both old and new barracks are within walking distance of the swimming pool and tennis courts.

#### FACILITIES AVAILABLE

Naval Air Station Moffett Field is a major Naval Base and as such maintains all the facilities normally found at a large Naval Base. Among these are:

Bank of America, Career Information and Counseling Center, Chapel, Commissary Store, Credit Union, Navy Exchange, Navy Regional Medical Center Oakland, Branch Facility (includes Dental), Service Station, and Hobby Shops

Personnel tentatively assigned to Naval Telecommunication Center Moffett Field should receive a copy of the Naval Air Station Information brochure, which contains detailed area information.

## SECTION ELEVEN - NAVAL TELECOMMUNICATION CENTER MONTEREY

### INTRODUCTION

The Monterey Peninsula is one of the world's loveliest areas to visit or to live. The county embraces some two million acres of mostly mountainous terrain, with a west boundary extending along the Pacific Ocean for 100 miles and an east boundary some 40 miles inland. Salinas is the county seat. One can sense the native pride of the people on the peninsula just from the names they have given their cities and communities - Pacific Grove, Carmel-by-the-Sea, Del Rey Oaks, Monterey, Sand City, Seaside, Carmel Highlands, Carmel Valley, and Marina. Each community has its own unique setting and its own special charm; such as the internationally known Monterey Jazz Festival held in September. People who have read John Steinbeck's Cannery Row and Sweet Thursday can see echoes of these stories in Monterey's Cannery Row. Most of the canneries are closed now, but the spirit of the old times lingers in restored shopping malls in the area.

### HISTORY

Naval Telecommunication Center Monterey became a part of the NAVCOMMSTA Stockton family in June 1972. NTCC Monterey is presently a tenant command of the Naval Postgraduate School, located 125 miles south of San Francisco on the beautiful Monterey Peninsula. The school officially settled in its present location in 1951. The famous Hotel Del Monte, once the most luxurious resort on the coast, attracting the rich and prominent from all over the world, is now renamed Hermann Hall and functions as the Administrations Building for the Naval Postgraduate School. The four-story Mediterranean style building, surmounted by a 120-foot tower which overlooks the sweeping peninsula skyline and beautiful Monterey Bay, is surrounded by sculptured gardens, including the famous cactus garden and its array of unusual cacti. You will also notice specimen trees, carefully marked by the Navy for their conservation, being considered perfect or unusual. A walk through the gardens is most refreshing and fascinating. Also included in the original purchase of the Del Monte Hotel was acreage adjacent to the Monterey Airport, which presently is the location of the Naval Postgraduate School Annex. This is the current location of NTCC Monterey, Building 700, Rooms 116 and 175.

Naval Telecommunication Center Monterey has an allowance of one officer and 19 enlisted personnel. It has communication guard for some 11 commands and Navy ships visiting the peninsula. There are full personnel support facilities located at Naval Postgraduate School and nearby Fort Ord Army Base.

### LIVING QUARTERS

**FAMILY LIVING QUARTERS:** There are 877 public quarters in the Navy's "La Mesa Village" for E-7 and above, located one and one-half miles from the Naval Postgraduate School campus. An additional 130

quarters are available for assignment to eligible enlisted personnel E-6 and below. These quarters are located at Fort Ord, approximately five miles from the Naval Postgraduate School. Assignment to these quarters is coordinated through La Mesa Village Housing Office.

Application for Navy housing must be accompanied by a copy of orders. Control date for placement on the waiting list is based upon the date of detachment from the previous duty station; provided advance application is made prior to detachment date and the date of detachment is confirmed within ten days of arrival in the area. Mail a completed Application for Military Family Housing (DD Form 1746) and a copy of your orders to:

TEMPORARY LIVING QUARTERS. The Navy does not have Temporary Living Quarters available in Monterey. Guest housing and visiting Officer quarters are sometimes available at Fort Ord Army Base or the Presidio of Monterey. Because the Monterey Peninsula is a resort area, advance reservations for motels are advisable, particularly during the summer months. Rates range from moderate to high.

#### PERSONAL SERVICES

HOUSEHOLD GOODS. For information and arrangements concerning household goods shipments, contact the Navy Personal Property Office nearest your residence or duty station. The Naval Postgraduate School Personal Property Office is located in Building 221, East Wing, Herrmann Hall, Room E-107A, telephone number (408) 646-2151. The AUTOVON number is 878-2151.

NAVY EXCHANGE. Most activities are centrally located in Building 301 on Fleming Road.

COMMISSARY STORE. There is no commissary at NPG; however, the Army commissary at Fort Ord is available. The main store is located in Building 4240 off Gigling Road.

#### MEDICAL AND DENTAL FACILITIES

MEDICAL SERVICES: The Presidio of Monterey Health Clinic is a combined services outpatient medical facility located on the Presidio of Monterey (in Building 422). As of 17 December 1976, the Army and Navy have undertaken a new mission in an effort to deliver comprehensive and quality medical care to active duty and dependent personnel of the Presidio of Monterey, Naval Postgraduate School, and its tenant activities. The Health Clinic operates under the concept of Family Practice which provides the opportunity to receive health care from a primary care physician/nurse team. The Naval Medical Administrative Unit located in the Presidio of Monterey Health Clinic is responsible for the coordination of medical care of all Navy and Marine Corps beneficiaries stationed in the Monterey area. The Unit maintains custody of the health records of all active duty Navy/Marine Corps personnel reporting for duty to the Presidio of Monterey, Naval Postgraduate School, or its tenant activities. The Silas B. Hayes Army Hospital at Fort Ord provides outpatient care for dependents, inpatient care, and consultation services. Military sickcall is held at the Presidio of Monterey Health Clinic Monday through Friday from 0700-0800. There is no sickcall on weekends or holidays. All eligible beneficiaries who require care on weekends or holidays are directed to the Acute Minor Illness Clinic at the Silas B. Hayes Army Hospital, which operates on a walk-in basis from 0730-2100 hours daily.

For emergency ambulance service, dial 911 (on base, dial 2333).

DENTAL SERVICES: The Dental Department is located on the fourth floor of Herrmann Hall. There is no designated period for sick call. Appointments may be made by telephone. Personnel having emergency conditions may report without having made prior arrangements. Telephone 646-2477/2478.

## RECREATIONAL FACILITIES

There is an 18-hole Navy Golf Course located behind the Monterey County Fair Grounds, including a driving range, pro shop and putting green. Also available on base are 12 tennis courts, swimming pool, badminton, volleyball, softball, bowling alley, and beautiful gymnasium. Also available through Recreational Services are sailing and deep sea fishing.

## GENERAL INFORMATION

1. EQUIPMENT: NTCC Monterey is equipped with a Mode I DCT-9000 Sat V, with card, magnetic tape, and paper tape capability.

### 2. WORKING HOURS

Watchstanders watch bill is 2 day watches, double back for 2 mid watches, then double back for 2 eve watches. At the completion of your last eve watch you will have 80 hours off. This is commonly referred to as a 2-2-2 and 80 watch bill.

### 3. INSPECTIONS

Inspections at this command are as follows:

Zone Inspections - Material inspections are conducted each Tuesday at 1000 by the AOIC and/or LPO.

BEQ/WEQ Inspections - BEQ/WEQ inspections are conducted twice a month on paydays at 1300 by the OIC, AOIC, or LPO. Each room inspected will be graded as outstanding, satisfactory, or unsatisfactory. Rooms graded outstanding will be exempted from the next inspection. All discrepancies listed will be corrected by the next inspection. For those rooms failing an inspection, a complete field day, followed by a reinspection will be conducted at 1300 on the first day of the occupant's 80.

Personnel Inspections - Personnel inspections are currently conducted at the discretion of the Commanding Officer, NAVCOMMSTA STOCKTON. All personnel inspections will be held in the Atrium. Occasional Dungaree Inspections are conducted at the discretion of the OIC/AOIC.

4. REQUEST CHITS - Personnel making requests which require command or departmental approval will submit request chits through their Chain of Command (supervisor, LPO, AOIC, OIC, NAVCOMMSTA STOCKTON XO).

5. **COMMUTED RATIONS** - All personnel are eligible to draw commuted rations upon arrival at this command. Meal passes will be issued by the Postgraduate School Personnel Officer for those who do not wish to draw commuted rations.

6. **LEAVE** - Leave will be granted whenever feasible. Leave requests are generated by a request chit routed through your Chain of Command. Once approved, the original is forwarded to NAVCOMMSTA STOCKTON Personnel Officer for typing of leave papers. Because of the delay in mailing request chits to Stockton, requests must be submitted 10 working days in advance. You may sign in and out on leave by telephone (646-2020/2070). However, you must be in the local vicinity when placing the call.

For emergency leave, contact the OIC/AOIC and let them know what has happened. They will have leave papers typed and have you on your way as quickly as possible.

7. **TRAINING** - The Training Petty Officer for the command, with the aid of the command Career Counselor, will ensure the following training/educational services are provided:

- a) Ensure correspondence courses, both enlisted and officer, are ordered expeditiously.
- b) Provide assistance to personnel desiring tuition aid to attend college-level courses.
- c) Provide assistance and information concerning off-duty education in the Monterey area.
- d) Ensure all enlisted personnel are given the opportunity to complete requirements for advancement in rate, i.e., required courses, PAR's M/L examinations, etc.
- e) Provide career counseling briefing on a scheduled basis.

8. **SECURITY** - NTC Monterey is located at the Naval Postgraduate School Annex in Fleet Numerical Weather Central's (FNWC's) building 700 adjacent to the Monterey Municipal Airport. Building 700 is physically located inside a fenced area with access gates on O'Hare and Halsey Avenues. These gates are open Monday through Friday from 0630 to 1800 and closed at all other times. The O'Hare gate can be opened by your keybadge when entering the compound, but the Halsey Avenue gate cannot. You may exit the compound through either gate by driving your vehicle's front wheels onto a designated area painted on the road which activates the gates.

You may also leave the compound when on foot by opening the pedestrian walkway gate adjacent to the O'Hare vehicle gate.

Inside the compound you will need a keybadge to enter certain areas of building 700. The FNWC Monterey Security Officer will determine the areas you need access to.

9. **POSTAL SERVICES** - All mail is picked up from the Naval Postgraduate School by FNWC. NTCC mail is picked up from FNWC twice a day by the Administrative Assistant and can be picked up by individuals from the front office. Your mailing address is:

10. **DRUG EXEMPTION REPRESENTATIVES** - The command has two drug exemption representatives. Personnel who have a drug or alcohol problem and wish to obtain information/assistance in combatting their problem, should contact one of the drug exemption representatives.

11. **HUMAN RELATIONS REPRESENTATIVE** - The command has one Human Relations Representative. Personnel who feel or believe theirs is a problem which crosses departmental/command lines should contact the representative for guidance.

12. **REQUEST CAPTAIN'S MAST** - All military personnel have the right to confer with the Commanding Officer. Personnel who feel or believe their problem cannot be resolved at a lower echelon may submit a request chit through their normal chain of command requesting Captain's Mast.

13. **NAVAL POSTGRADUATE SCHOOL BUMPER DECALS** - The NPS Security Office issues bumper decals to NTCC Naval personnel which allow them to enter the school grounds at night and to park in various parking areas at the school and annex. The Security Office is located adjacent to the Quarter Deck in Herrmann Hall.

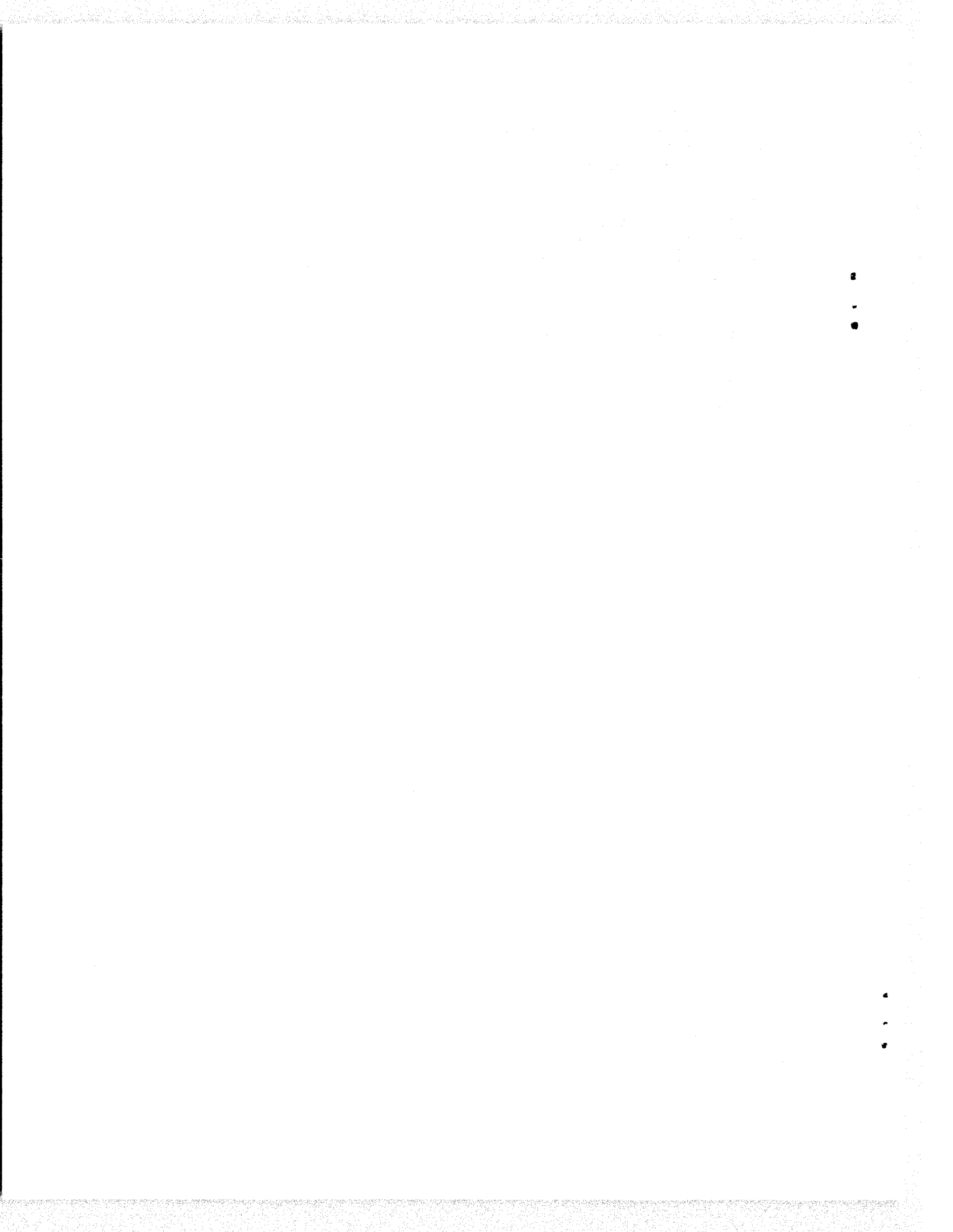
14. **ACTIVITIES** - There are many activities you may get involved in during your tour at NTCC. Some of these activities are as follows:

a) **NTCC Recreation Committee** - This committee is the focal point for many activities or functions which occur at NTCC. Recommendations made by this committee and approved by the Recreation Council and the OIC consist of: Christmas parties, fishing trips, quarterly recreation outings, picnics, etc.

b) **NPS Enlisted Club Advisory Board** - Members on this board represent all enlisted personnel from the various Naval commands and activities attached to the Naval Postgraduate School. Their functions are to alert management of problem areas which should be corrected and ideas which could improve the operations of the club. NTCC has a primary and an alternate member on this board.

c) Little Theater - The Naval Postgraduate School has a very active Little Theater group sponsored by the Recreation Department. The year's program usually includes a fall comedy or drama, a children's Christmas show, a spring musical and one or two children's plays in the summer. You and members of your family are most welcome to join. Membership meetings are held quarterly. These meetings, try-outs, and show dates are always well publicized. No acting experience is required and back-stage workers are always needed if you prefer to work "behind the scenes." Information can be obtained from the NPS Recreation Officer, extension 2466/7.

d) Monterey Navy Flying Club - Open to all active duty military, dependents, retired military, and civil service workers. Instruction in flying at moderate rates is available. For information, call 373-7033 (commercial).



SECTION TWELVE -- NAVAL RADIO STATION (T)  
JIM CREEK, OSO, WASHINGTON

The Naval Radio Station at Jim Creek is located in the foothills of the Cascade Mountains about 60 miles northeast of Seattle. One of the world's highest-powered radio transmitting stations, it lies in the Jim Creek Valley between Blue and Wheeler Mountains.

The station was opened in November 1953 with the primary mission of providing communications to the Pacific Fleet.

The station includes 4,894 acres with four lakes and two streams. There are black bear, deer, grouse, rabbit, bobcat, fox and coyote on the station; as well as several species of trout in the lakes and streams. Some areas are seasonally open to the general public, and camping facilities are available through area Special Services branches.

Jim Creek is an ideal site for radio transmitting because of the two mountains approximately 3,000 feet high and of adequate size to support the huge antenna. Also, there is a sufficient supply of water for cooling the transmitter.

The antenna consists of ten spans of copper-clad steel cable of varying lengths of 6,600 to 8,500 feet, suspended across the valley from 12 200-foot towers atop the mountains and fed by about 30 miles of transmission lines.

The number of personnel at the station consists of two military (one officer and one senior chief petty officer), and 36 Civil Service employees. Annual payroll and other purchases which impact the local economy amount to approximately \$700,000.
